It was **resolved**, with no votes to the contrary, to elect Cllr Miss Goodger as Chairman.

- 1805/54 **To note thank you letter from the Community Group**  
It was **resolved**, with no votes to the contrary, to note the information.
- 1805/55 **To review hire charges**  
Members considered the hire charges for Parish Council facilities and it was felt that hire charges should be the same where possible. It was **resolved**, with no votes to the contrary, to set the hire charge for the Beechfield Playing Field and Village Green at £10 per hour for commercial hire with a deposit of £100 and £5 per hour for charity with a deposit of £50. It was **resolved**, with no votes to the contrary, to defer consideration of the hire charge for the Beechfield Centre until the centre is replaced.

Implementing the structure of the hire charges and deposits would be at the discretion of the Clerk.

It was noted that it had already been agreed that if a charity event is being held that does not restrict parishioners from using the facility then the hire will be free of charge and the Committee will review the hire charges at the next Committee Meeting.

It was further **resolved**, with no votes to the contrary, to recommend to the Fremington Quay Committee that the same pricing structure be implemented for Fremington Quay.
