Cllr Brailey reported that the executive committee had agreed the release of the £12,300.30 S106 money for the replacement of the Beechfield Centre project and a cross party committee is looking at the Pannier Market and how to make it more attractive.

Cllr Biederman thanked the executive for agreeing the funds.

1806/12 To receive and consider Applications for Co-option for Fremington/Yelland Ward

Four applications for co-option were received and circulated to members before the meeting and as follows:

Each candidate was asked to speak in support of their application and answer questions.

Mr B Eardley and Mr T Furness entered the meeting at 7.20pm.

The Chairman proposed and it was seconded by Cllr Biederman that voting on this item should be undertaken by a Secret Ballot. It was **resolved**, with no votes to the contrary, to vote by Secret Ballot.

Voting slips were issued to all Councillors and voting was as follows:

- 0 Peter Davies

It was therefore **resolved** to co-opt Mr Samuel Adams onto Fremington Parish Council to represent the Fremington/Yelland Ward. The Declaration of Acceptance of Office was signed and delivered.

The Chairman proposed and it was unanimously agreed to move item 18 on the Agenda forward to this point followed by item 19.

To receive presentation on the findings and feasibility of Community Renewable Energy (Energy Analysis to report)

Mr Eardley outlined the findings from the feasibility report for Community Renewable Energy within the parish. He explained that the Solar PV on the Brynsworthy Environment Centre would be the most feasible project, however, the District Council has indicated that it would wish to take this project forward and would not want it to be part of a community scheme.

Cllrs Brailey and Biederman declared a Personal Interest as members of the North Devon Council.

Mr Eardley spoke further on the Brynsworthy site and other sites that had been considered, including Petroc (although it is not in the Parish it could provide benefit to the Parish), there was either not high enough day time demand for the alternative locations or landowners would not permit a scheme.

There is a technically viable scheme at Fremington Quay but not financially viable at the moment, however, it could be a medium to long-term project as costs reduce.

It was **resolved**, with no votes to the contrary, to keep the document under review for such a time when a scheme may become viable.

Mr Eardley and Furness left the meeting.

1806/14 **To consider representations on cuts to Mental Health** (item requested by Cllr Ms Scott)

Cllr Ms Scott gave members details of waiting times for access to children's mental health services and the implications this can cause for families and the children. Cllr Ms Scott was concerned about the wait times and lack of professional help for young people.

Cllr Biederman explained that it is a major problem in the area and Devon County Council is undertaking a lot of work around raising awareness, he felt it would be useful for Cllr Ms Scott to address DCC at County Hall.

Members discussed the issues around children's mental health care and the responsibilities, it was mooted that schools should take more responsibility but also noted that their resources for dealing with these situations are limited and reduced.

After much discussion and debate it was **resolved**, with no votes to the contrary, for the Parish Council to write to Devon County Council, the Healthcare Trust and the MP to express the concerns raised and request a meeting with the three parties and Cllrs Ms Scott and Biederman.

Cllr Biederman declared a Personal Interest in the following item.

The scheme requires a guardian of the board and Cllr Cann offered to fund a board along with Cllr Mrs Flynn if the Council would support a board at Fremington Quay and/or Tews Lane once the building had been completed. It was **resolved**, with no votes to the contrary, to support a board at Fremington Quay.
