1602/12 **Declarations of Interest** 

Cllr Ms Scott declared a Personal and Prejudicial Interest in Item No. 1602/28 60445 as the applicant is a neighbour of her parents.

1602/13 Chairman's Announcements

The Chairman announced that the Parish Council had finally managed to open a 3 month fixed term deposit account. The Clerk first attempted to set up the account in July 2015 and after several false starts the account was opened on the 2<sup>nd</sup> December 2015.

Due to the length of time Lloyds has taken to open the savings account and the interest lost, the Clerk wrote a letter of complaint on behalf of the Council. In response Lloyds has apologised for the situation and the delays that have been caused. In addition, the bank has credited the Parish Council's account with a total of £532.01 to cover lost interest, call costs and the Clerk's time in dealing with the matter. The Council thanked the Clerk for her efforts in dealing with this matter.

The Chairman announced that Cllr Biederman had a cheque to present to the Council on behalf of the Fremington and District Community Group for £925 to contribute towards the play equipment repairs at the Babbages Play Area and for the maintenance to the shrub by the bus stop at Taw View. The Council thanked the Community Group for its kind contribution.

The member of the public stated that 15 samples had today been taken from the former army camp site. Cllr Biederman reported that he would hope this was part of ongoing monitoring of the site and it was agreed to write to NDC to ask if samples had been taken and if so to request a copy of the results.

A member of the public stated that there are not any worms in the soil on the former army camp because the soil is "toxic".

Cllr Biederman reported that draft budgets were being considered at both DCC and NDC and it was difficult to find the savings required. He reported that DCC is considering the loss of Lollipop men and women and he has put in an amendment to keep this valuable service. Cllr Ms Scott asked if the renewal of school bus passes for every term could be investigated.

1602/22 To receive update from the Fremington Neighbourhood Plan Steering Group

Cllr Mrs Kingdom reported that representatives of education, health, transport, employment and sport had been invited to sit on the Steering Group, terms of reference had been adopted and the group would be meeting on the last Thursday of every month at 9am.

To receive correspondence relating to proposed sewer route at Queen Elizabeth II Playing Field

Members considered the correspondence and it was **resolved**, with no votes to the contrary, to ask if there would be an opportunity for compensation of the inconvenience to improve the drainage on the left hand side of the field.

1602/24 To receive correspondence relating to the Combined Authority Devolution

Members received the Devolution for the Heart of the South West a Prospectus for Productivity document. Cllr Chalmers reported that DALC would be holding a special meeting on the 18<sup>th</sup> February to discuss the Devolution and there are concerns on how combining 22 authorities across Devon and Somerset will impact on Town and Parish Councils. There were also concerns that there was little mention of North Devon, Agriculture and Tourism in the document and would like to know what the benefits will be for North Devon.

It was **resolved**, with no votes to the contrary, to invite Cllr Brailey as the leader of NDC to give a presentation at the next Full Council Meeting on the Devolution.

1602/25 To receive and consider Help us Clean for the Queen

Members considered taking part in the Clean for the Queen event and it was **resolved**, with no votes to the contrary, for Councillors to lead on a project in each ward on Saturday 5<sup>th</sup> March 2016 at 10am. It was agreed that Cllrs Biederman and Groves would organise Fremington meeting at the New Inn Car Park, Cllr Bell and Mrs Dyson Yelland meeting at the former Post Office, Cllr Chalmers would lead in Bickington with Cllrs Mrs Flynn and Cann if available and would meet in the car park, Cllr Mrs Kingdom would lead in Roundswell with Cllr Turner if available and would meet at McDonalds and Cllr Sherborne would lead Woodville to meet at the School. It was agreed to circulate to all Councillors to help lead projects in their areas.

1602/26 To receive further information relating to the Future of the North Devon Records Office

Members received an update on the long term funding for the North Devon Records Office from Barnstaple Town Council. Members were disappointed that the Parish Council had not been invited to the Stakeholder Meeting. The Parish Council still has concerns that there is not enough detail for the Council to be able to make a decision by the end of February and would like to know:

- What other sources of revenue have been investigated
- A clearer indication of the strategic plan for future funding and revenue
- Has the possibility of joining the service with the Museum been investigated?
- Why aren't businesses that benefit and district councils involved in the rescue package?

Cllr Biederman declared a Personal Interest in the following item as a County Councillor.
