1506/02 **Declarations of Interest**

Cllr Biederman declared a Personal and Prejudicial Interest in Item 59295 as the proposed application is next to his property.

Cllr Groves declared a Personal Interest in Item 55433 as the owner of the property.

1506/03 Chairman's Announcements

The Chairman announced that there would be an informal workshop for Councillors to express issues of concern on Wednesday 8th July 2015 at 7pm in the Annexe. District Councillors submitted their apologies for the meeting as it clashes with NDC's Full Council meeting.

The Chairman reported on the meeting that had taken place with other authorities, the MP and residents regarding Military Road and congratulated Cllr Mrs Flynn on her appointment as Chairman of the District Council.

1506/09 To receive and consider Applications for Co-option for Fremington Roundswell and Woodville Wards

Four applications for co-option were received and circulated to members before the meeting and as follows:

The Chairman proposed and it was seconded by Cllr Chalmers that voting on this item should be undertaken by a Secret Ballot. It was **resolved**, with no votes to the contrary, to vote by Secret Ballot.

Each candidate was asked to speak in support of their application and answer questions, unfortunately Mr Richard Jones was out of the country on annual leave and unable to attend the meeting; members considered the absence and **resolved**, with one vote to the contrary, to consider the application.

Voting slips were issued to all Councillors and following a vote it was **resolved** to co-opt Mrs McCormack-Hole to Roundswell Ward and Mr Alan Rennles to Woodville Ward. Declarations of Acceptance of Office were signed and delivered.

To receive resignation from Cllr Mrs Kingdom as the Parish Council's representative on the Tomlin Hall Management Committee and appoint a replacement representative

Cllr Mrs Kingdom's resignation was received and it was **resolved**, with no votes to the contrary, to appoint Cllr Mrs McCormack-Hole as the representative on the Tomlin Hall Management Committee.

1506/11 To consider plans for residents' parking and double yellow lines (Item requested by Cllr Biederman)

Cllr Biederman circulated proposals for proposed parking restrictions along Higher Road and Beechfield Road. Cllr Biederman felt the yellow lines proposed for Beechfield Road should continue along past the play area. It was **resolved**, with no votes to the contrary, to support the proposals in principle with the addition of the extended yellow lines along Beechfield Road and subject to a public consultation.

1506/12 To appoint six Councillors to undertake training on the use of the Defibrillator

It was **resolved**, with no votes to the contrary, for Cllrs Ms Scott, Mrs Flynn, Mrs Kingdom, Biederman, Chalmers and Mrs Dyson to attend the training. It was further **resolved**, with no votes to the contrary, to ask Cllr Wood if he would like to undertake the training.

1506/13 To consider receiving Agendas and associated paperwork via e-mail

Members considered receiving Agendas and associated paperwork via e-mail and it was **resolved**, with no votes to the contrary, to send all Full Council Agendas to Councillors via post. All Committee Agendas will be sent to Councillors, with the exception of Cllrs Mrs McCormack-Hole and Sherborne, via e-mail.

1506/14 To receive and consider Electoral Review of Devon: Draft Recommendations

The information was circulated to members prior to the meeting and it was **resolved**, with no votes to the contrary, to note the information.

1506/15 To receive correspondence relating to the Parish Council's Right of Way

Proposals to fence the area were received and circulated to members. It was **resolved**, with no votes to the contrary, to accept the proposals subject to the Parish Council's Right of Way being a minimum width of 3m and the Parish Council being supplied with keys to the gates at either end.

1506/16 To consider funds from Dog Bags Ear Marked Reserve to be veered towards grass cutting within the Parish

Members were informed that due to DCC's cuts the Parish Council was investigating ways in which the funding gap to undertake this year's highways grass cutting could be met. There was an Earmarked Reserve of £1,600 for the purchase of dog bags it was felt this money could be veered towards to the grass cutting for this year, the reserve could then be built up again before the next purchase. Ways in which the highways grass cutting could be sustained for future years would need to be investigated. It was **resolved**, with no votes to the contrary, to veer £1,600 from the dog bags EMR to highways grass cutting.

1506/17 **Highway issues – update**

Cllr Ms Scott reported that the 40mph sign as you are entering Muddlebridge from Bickington is very dirty and facing the hedge. Members were concerned at the state of the signs throughout the parish and felt this should be drawn to the attention of DCC as a lot of the signs are unreadable.

It was **resolved**, with no votes to the contrary, to suspend Standing Orders to allow members of the public to speak on the item.

A member of the public was concerned at the large vehicles coming out of Military Road and turning into Higher Road, continuing along Beechfield Road as they are unable to turn right out of Military Road. The member of the public was informed that at the recent meeting it was agreed that the islands would be trimmed so the vehicles can turn right out of Military Road.

It was **resolved**, with no votes to the contrary, to reinstate Standing Orders.

Cllr Cann reported that he was still the Executive member for Environment and NDC is hoping to rush through the Local Plan. He was concerned at how dismissive the Inspector had been of the impact on the Estuary when determining the Mead Park development and would be organising a public consultation to ascertain how members of the public view the Estuary.

Cllr Biederman congratulated Cllr Mrs Flynn on her appointment as Chairman of NDC and reported that the Allenstyle application would be discussed at Wednesday's NDC Planning Meeting.
