
To consider quotation and location of Pump Track for Fremington

Members considered the quotation received for a pump track, which was £69,995 + VAT, and the advice on the most appropriate location to install a facility for wheeled sports within Griggs Field. Members did not feel that Griggs Field was a suitable location for such a facility and also felt the price was not viable at the present time. It was **resolved**, with no votes to the contrary, not to proceed with a wheeled sports facility in Griggs Field and not to proceed with a Pump Track at this time but to look at the facilities in line with community aspirations and the Neighbourhood Plan.
