Cllr Mrs Dyson declared a Personal and Prejudicial Interest in Item 1711/28 Planning Application 63468 as the development is opposite her house.

It was **resolved** to agree the agenda between Part A and Part B (Confidential).

1711/26 Public Participation Period

A member of the public made representations against planning application 63468, although the plans had been amended there would still be an adverse impact on the view and would set a precedent for the rest of West Yelland and future development, they did not believe that two storey properties should be allowed in this area.

A member of the public raised concerns about vehicles entering Ellerslie Road during the restricted hours. It was noted that the Police did not see this as a priority and had asked DCC to consider removing the restriction. Cllr Cann felt this had been a problem for many years and was dismayed by the reaction of the Police. It was agreed to write to the Police Commissioner to express the concerns.

Mr Cattermole explained that changes had been made to planning application 63468 the Planning Inspectorate designated a certain area that had to be one storey and the two storey properties are outside of this area; due to the topography of the area the two storey houses won't appear two storey.

The District Councillors were reserving their final views on the applications until they were in full possession of all the relevant arguments for and against

Cllr Mrs Dyson declared a Personal and Prejudicial Interest and left the meeting for the following item.

63468 Proposal: Reserved matters application following outline planning consent 57663 & S73 permission 62914 (variation of conditions 4 (access) & 5 (development parameters) attached to planning permission 57663 to allow the substitution of plans 0692-PHL-01 rev E (access arrangement), 6525-00-022 (built land use plan), 6525-00-019 (illustrative masterplan) & 6252-00-028 (concept masterplan) with 16022-100-C (access arrangement), 1759-1022 (built land use plan) & 1759-1028 (indicative masterplan) (outline planning permission 57663 is for up to 135 dwellings plus infrastructure including the creation of a vehicular access to B3233. provision of open space, landscaping, allotments, ponds & other associated development - all matters reserved except access) in respect of erection of 135 dwellings, public open space, allotments, landscape planting, pedestrian, cycle & vehicular links & associated furniture together with discharge of conditions 1,5 & 6 (amended plans) Location: Land adj B3233, West Yelland, Yelland, Barnstaple Applicant/Agent: David Wilson Homes

It was **resolved**, with no votes to the contrary, to recommend REFUSAL. The Parish Council has concerns about the two storey dwellings which they feel will adversely affect the area and amenity of the residents, although the amendments that have been made are an improvement the Council still feels they are contrary to the Planning Inspectors aspirations of an open view. If the North Devon Council is minded to approve the Parish Council would request a site meeting is undertaken.

Two members of the public and Mr Cattermole and Miss Jenkins left the meeting.

Cllr Mrs Dyson returned to the meeting.

1711/30 Councillors Questions

Cllr Wood explained that the Planning Inspector does not approve of the proposed land supply that has been put forward in the Local Plan and would like to see more especially in West Yelland.

Cllr Cann explained that the Planning Inspector does not believe the 5 year land supply put forward plus a 10% buffer is deliverable within the 5 years.

Cllr Ms Scott made comments about the bad planning in this area, especially with the highways, and the knock on effect on missed appointments and travelling to school.

Cllr Cann explained that the highway network is the responsibility of Devon County Council and as the highway authority DCC quite often undermines the District Council and approves proposals included with developments.

Discussions centred on these comments.

Cllr Cann left the meeting.

Cllr Chalmers explained that the Planning Inspector for Mead Park actually requested that DCC attends the enquiry to support its view.

It was agreed to ask the Clerk to place an item on the next Agenda to consider representations to the Government on highway issues.
