Members were informed that a letter had been received from Go North Devon asking the Council to consider adding an amount to the precept for a standing grant. It was **resolved**, with no votes to the contrary, to inform Go North Devon of the grants process.

Cllr Rennles left the meeting at 11.30am.

1711/51 To consider draft budgets for 2018-2019

The draft budgets were circulated prior to the meeting. The Committee was informed that the Parish Grant received from the North Devon Council would be reduced by 50% in 2018-2019 and to 0 by 2019-2020. The Committee felt that the budgets would have to realistically reflect the costs of the Parish Council over the forthcoming financial year. It was noted that the Parish Council's tax base had increased significantly and was continuing to increase and after consideration it was agreed to recommend to Full Council that the precept be increased to allow for a realistic budget.

1711/52 To consider re-investing Parish Council funds

Members considered the projects that would be started next year and the Ear Marked Reserves that would be used. After consideration it was **resolved**, with no votes to the contrary, to invest £50,000 in two, three month fixed term deposit accounts.

1711/53 To consider application to the Public Works Loan Board for the replacement of the Beechfield Centre

Members considered the project costs, the Ear Marked Reserves for the project and the Section 106 funding that had been received. It was noted that the Parish Council could apply to the Leader 5 grant funding stream, as long as the outputs were strengthened, however, the timescale for applying and gaining a grant were not compatible with the timescale for the project. The Committee noted that the interest rates were low and there were only two payments outstanding on the Public Works Loan for the purchase of Griggs Field. The replacement of the redundant old portacabin with a permanent community building, to include Parish Council Offices, had been an aspiration for over ten years. It was **resolved**, with no votes to the contrary, to recommend to Full Council that the Parish Council applies to the Public Works Loan Board for a loan of £150,000 to complete the replacement of the Beechfield Centre.
