The Chairman reported that a condition of the Linden Homes planning consent meant the upgrade of the footpath and road in Tews Lane, in order to achieve this the developer would require a small section of the land leased by the Parish Council. It was noted that a decision would need to be taken by the Committee in due course on whether or not to release this land but the Chairman felt there should be commercial value to this land and this should be pursued before a decision is taken. The Committee agreed and asked that the Chairman and Clerk pursue before bringing to Committee for consideration.
- The Chairman further reported that the first stage of the drainage repairs had been completed with a further CCTV survey carried out, the report had only been received the day before the meeting and the Clerk was investigating the results.
