**Declarations of Interest** 

Cllr Ms Scott declared a Personal Interest in Item 1809/14 as her parents live at the Quay.

Cllr Biederman declared a Personal Interest in Item 1809/20 application 65230 as the applicant is known to him.

1809/03

**Chairman's Announcements** 

The Chairman informed members that she had been invited by the Army to a presentation at the Landmark Theatre on 25<sup>th</sup> September which unfortunately she could not attend and asked if any member would like to attend in her place to let the Clerk know.

1809/04

To agree the agenda between Part A and Part B (Confidential)

It was resolved to agree the agenda between Part A and Part B (Confidential).

1809/05

To receive a report from the Police/Councillor Advocate

The report was circulated and is attached as Appendix One. Cllr Chalmers, as the Cllr Advocate, reported that he had received a presentation on cybercrime and, although there are not any indications of reports within the parish, it is likely to be an issue and it is important to identify and support victims, it was noted that domestic and sexual abuse is also a problem and a lot of incidents go unreported. The Parish Council has been offered the same presentation and it was agreed to accept the offer and invite the other three parishes in the Fremington Rural Ward, members felt it would be nice to arrange alongside a community safety evening and it was agreed to delegate to the Clerk to organise in conjunction with Cllr Chalmers.

1809/06

**Public Participation Period** 

A member of the public explained that there are not any road markings in Mead Park and was concerned that there would be an accident. It was noted that this had been reported to Cllr Biederman via the Clerk and Cllr Biederman confirmed he would chase, however, he did not believe that the road had been adopted yet.

1809/07

To approve and sign the minutes of Fremington Parish Council meeting held on Monday 6<sup>th</sup> August 2018

Copies were circulated with the agenda.

It was **resolved**, with no votes to the contrary and two abstentions, to approve and sign the minutes of the meeting on the 6<sup>th</sup> August 2018 as a correct record. Cllr Mrs Kingdom duly signed the minutes.

#### 1809/08 Highways issues – update

Cllr Chalmers raised concerns about the dangerous conditions when the lights are switched off around Church Hill and its junctions with Higher and Military Road. Cllr Biederman explained that he had raised the issue and asked if it is or is not safe and if it is why the lights were installed. He further explained that due to traffic issues the working day had to be shortened and therefore the works have been delayed.

Cllr Ms Scott reported that there are several road closures of main routes taking place at the same time which will put more pressure on the B3233.

Cllr Crawford asked about the re-painting of the cycle and footpath signs on the tarmac in Roundswell and asked if the Residents' Association could repaint them. Cllr Biederman explained that there are blue signs which denotes the sides and unfortunately in the current climate it is unlikely that DCC will be able to repaint, if the Residents' Association wishes to repaint the markings they should seek permission from DCC.

Cllr Cann raised concerns about the congestion in the parish and the additional developments due to be built and asked how DCC is going to deal with the increase. He noted that DCC, on highway grounds, had approved the planning applications and asked again on what grounds and how this is going to be dealt with.

Cllr Biederman explained that the Parish and District Council refused most of the applications and the decisions were overturned, the attitude of DCC is "see what happens when Larkbear is built", there is a Government Agenda to facilitate building. The developments were approved in line with the NPPF, HATOC agreed 18 months ago to look at the situation and he felt the Parish Council should write to DCC.

It was agreed to write a letter to DCC explaining the situation is getting worse and asking for details on how DCC proposes to deal with the congestion.

It was **resolved**, with no votes to the contrary, to note the information.

1809/10 **County and District Councillors' Reports** - To receive reports from the County Councillor and District Councillors for information only.

Cllr Biederman apologised for missing the July meeting as he was at the LGA conference and the August meeting for which he was on holiday. Cllr Biederman asked members not to wait until the meeting to report highway issues and explained it was better to report them to him via e-mail or online. Cllr Biederman reported that the LGA conference had been useful it had highlighted that the issues experienced were nationwide. He explained that children's' services was already looking at an £8m overspend and agreed that cybercrime and mental health were issues for the area.

Councillor Biederman explained that as a matter of course County Councillors are not DBS checked even though they are invited into schools and other facilities with vulnerable people and the question has been asked should they be DBS checked.

1809/11 To appoint one Cllr to sit on the Parks and Playing Fields Committee

Cllrs Adams and Crawford were nominated for the position and when put to the vote 7 were in favour of Cllr Adams and 6 Cllr Crawford. It was therefore **resolved**, to appoint Cllr Adams to serve on the Parks and Playing Fields Committee

1809/12 To consider a request to place a border, chippings and wooden cross on a burial plot in Fremington Cemetery

It was **resolved**, with no votes to the contrary and one abstention, to approve the request.

1809/13 To consider an amended request for a bench to be sited in Fremington Cemetery

It was **resolved**, with no votes to the contrary and one abstention, to approve the amended request.

1809/14 To consider providing a statement of truth for the Land Registry to support the North Devon Council's application for registration of land at Fremington Quay

Members considered the request and the areas for registration and it was **resolved**, with no votes to the contrary and one abstention, to provide a statement of truth for the areas hatched in green on the map attached as Appendix Two which are areas that the Parish Council has been occupying and maintaining.

1809/15 To consider request to support an application to the Communities Together Fund for a new Martial Arts Hub for North Devon

Members considered the request and it was **resolved**, with no votes to the contrary, to indicate the Parish Council's support in principle and to refer the request to the Communities Together Fremington Rural group for consideration and to seek the advice from the North Devon Council.

- To consider attendance at the DALC AGM (item requested by Cllr Chalmers)
  Cllr Chalmers explained that the AGM would be held on the 3<sup>rd</sup> October and the
  Chief Constable would be giving a presentation on the proposed merger, it would
  also be a good opportunity for another Councillor to see the work of DALC. It was
  resolved, with no votes to the contrary, for Cllrs Adams and Mrs McCormackHole to attend the AGM with Cllr Chalmers.
- 1809/17 To receive Cllr Chalmers resignation as the Tomlin Hall Representative and appoint a replacement Representative

It was **resolved**, with no votes to the contrary, to accept the resignation and appoint Cllr Mrs Cann as the Parish Council's Tomlin Hall Representative.

1809/18 To consider LGA green paper for adult social care and wellbeing consultation

Members raised concerns that the consultation was complicated and there had not been a long enough consultation period. Cllr Crawford informed members that he had spoken to NALC and had been told that a green paper is usually a consultation period of three months and an extension could be requested, he felt it was an important consultation which should be given careful consideration.

It was **resolved**, with no votes to the contrary, to request an extension and delegate a response to the Clerk in consultation with a Working Party consisting of Cllrs Mrs McCormack-Hole (who would arrange a meeting of the Working Party and feedback the responses to the Clerk), Mrs Cann, Crawford and Chalmers

# To receive update on the future management of the Multi Use Games Area on the former Army Camp Development Site, Riverside Park and consider the adoption

The Chairman reported that there are a number of issues with the MUGA at the moment including a risk of a nuisance claim if damage to a neighbouring property continues, a possible lack of planning permission for building on listed land and management concerns raised by residents of Riverside Park. The advice from the Parish Council's Solicitor was clear in that the Parish Council should not adopt the MUGA until the current owner addresses the issues.

Cllr Cann explained that the Parish Council had agreed to adopt in principle on the basis this would be an asset, however, it is looking more like a liability and with the current issues makes it almost unmanageable. Cllr Cann felt the Parish Council would need to face the possibility that the Parish Council may not accept part or all of the open space.

Cllr Rennles was concerned about the safety of the listed wall, it was noted that the Parish Council had raised this issue with the Planning Officer previously.

It was **resolved**, with no votes to the contrary, to defer consideration of this item until the Working Party has met with the Developer and Planning Officer at the site meeting currently scheduled for the 20<sup>th</sup> September 2018.
