1811/02 **Declarations of Interest**

Cllr Ms Scott declared a Personal and Prejudicial Interest in Item 1811/07 applications 65724 & 65723 as she teaches the applicant's children.

Cllr Biederman declared a Personal Interest in Item 1811/22 as a member of the County Council and Item 1811/25 as Chairman of the Community Group.

The Chairman informed members that she would discuss the Strategic Review with members after the meeting.

The report was circulated and is attached as Appendix One. Cllr Chalmers reported that he was in discussions with the PCC Office and hoped the Cyber Crime presentation could be scheduled for the December meeting.

1811/06 Public Participation Period

A member of the public spoke on behalf of the applicant and in support of planning application 65724.

Cllr Crawford entered the meeting.

The member of the public explained that there are two certainties in life, you are born and you die, she explained that she had used Gayton's for over 40years and had found them to be professional. She explained that they had outgrown their current premises and it makes sense to have all of the services in one place, a bigger facility was required due to the increase in population. She could see no issue with the proposed location although she would have an issue if it was a housing estate that was proposed.

A member of the public was concerned that the traffic survey was carried out in the wrong location outside of the Methodist Chapel and did not count those vehicles turning onto Mill Road so will not have counted all of the traffic travelling past the site. It is outside the Local Plan and agricultural land.

A member of the public explained that she was speaking on behalf of 16 households and the Save Fremington campaign. She explained that the proposal pushes the urban boundary out into the countryside and opens a gap between which will create infill up to the Gayton's site. She explained that there are conflicts with several policies and does not meet the definition of sustainability.

She raised traffic issues and the impact on the ecology of the site and explained that there are EU protected Horseshoe bats in this area.

She felt that the office could be separate to the rest of the facility and there was no need for the residential unit.

The applicant's builder explained some technical aspects of the application, he explained that the traffic counters were placed as requested by Devon County Council, the Highway Authority, and he believed this location was chosen because it is the narrowest point so the area most likely to experience conflict. He explained that the Local Plan talks about the protection and provision of essential services, however, there was no engagement during the process with funeral directors and the capacity. A small amendment has been made to the application to provide a bat friendly external lighting scheme.

Cllr Biederman proposed and it was unanimously agreed with three votes against to move item 18/11/07 application 65724 forward to this point.

Cllr Ms Scott declared a Personal and Prejudicial Interest and left the meeting for the following item.

Cllr Mrs Mackie reported that the Local Plan had been adopted and gave an overview of the process. Cllr Mrs Mackie reported that there would shortly be a consultation on parish boundaries but this did not affect Fremington Parish at this time, she explained that there would be a Healthcare in North Devon meeting with Torridge and the North Devon District Councils and this week is responsible gambling week. Cllr Mrs Mackie further reported that there would be a Purple Tuesday which aimed to raise awareness about making shops and retail more accessible.

Cllr Cann reported that he was "delighted" that the Local Plan had finally been adopted.

Cllr Brailey was also pleased that the Local Plan had been adopted and expressed the difficulty in preventing developers prior to the five year land supply. Cllr Brailey reported that he had met with the CEO of the RD&E, North Devon Hospital Trust to discuss the way forward for the hospital and to remind her of the importance of the hospital to the area, he explained that there are two issues the first being funding and the second a lack of doctors which is a worldwide issue.

Cllr Biederman explained that keeping the five year land supply could be a challenge and explained the budget pressures on the County Council especially in children's services with an increase in demand. He explained that DCC was proposing to stop all attendance at conferences to cut costs. Cllr Biederman reported that there would be a trial of traffic lights on the Cedars Roundabout in January and he had raised speeding along the B3233 with HATOC.

Cllr Mrs Kingdom asked if the traffic lights would only be for the morning rush hour, Cllr Biederman thought so but would clarify.

Cllr Mrs Cann reported that she had attended along with Cllr Chalmers and they noted that the lights were pointing down and did not feel they would interfere with residents.

Cllr Cann felt it was inappropriate to have the lights in such close proximity.

Cllr Biederman explained that the shadowing reached to the other side of the road but was no worse than the street lighting.

It was **resolved**, with no votes to the contrary and five abstentions, that the lighting is acceptable.
