- 1812/21 **Declarations of Interest**
Cllr Rennles declared a Personal Interest in Chairman's Announcements for the Street Naming and Numbering application relating to Yelland Quay.
- 1812/22 **Chairman's Announcements**
The Chairman announced that two Street Naming and Numbering consultations had been received for Yelland Quay and the development at Chilpark, unfortunately the consultation deadline could not be extended and therefore details would be circulated, members were asked to inform the Clerk of any objections.

It was **resolved** to agree the agenda between Part A and Part B (Confidential).

It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the meeting on the 3rd December 2018 as a correct record. Cllr Mrs Kingdom duly signed the minutes.
- 1812/27 **To consider detailed quotation for the next stages of the Neighbourhood Plan**
The detailed quotation from Planning Partnership Ltd to produce the draft plan was circulated prior to the meeting, it was noted that the next stages will include:
1. Interpretation of survey/consultation responses and initial evaluation of issues of primary concern, along with assessment of whether these are matters that can be addressed by a Neighbourhood Development Plan (NDP) or whether they require other actions
 2. Outline the types of policy solutions available through NDP process for the principal issues under 1 above. Additional analysis of how many issues it is practical or desirable to cover in NDP
 3. Present above analysis to Steering Group or Fremington Parish Council as required
 4. Based on outcome of 3. above, prepare initial draft policies for those areas FPC/Steering Group provisionally wish to take forward into NDP
 5. Present draft to FPC/Steering Group
 6. Draft supporting text to policies
 7. Informal discussion with North Devon Council
 8. Present final draft of NDP to FPC with supporting report
 9. Undertake publicity/consultation prior to Reg 14 submission
 10. Undertake analysis of responses to Reg 14 consultation / make any corrections / prepare consultation statement to accompany Reg 15 submission to LPA. Submit NDP for examination

It was further noted that the majority of the plan was being delivered through grant funding with a contribution already earmarked from the Parish Council. Members felt that it will be an important document which, once adopted, would strengthen the communities' position in line with the adopted Local Plan. The quotation received was felt to be very competitive and the experience of the former planning officers invaluable. It was therefore **resolved**, with no votes to the contrary, to accept the quotation from Planning Partnership Ltd to take the Neighbourhood Plan through to a draft document.
