- 1905/79 **Election of Chairman**
RESOLVED: That Cllr F Biederman be elected as Chairman for 2019/20. (NC)
- 1905/80 **Election of Vice Chairman**
RESOLVED: That Cllr Mrs S Kingdom be elected as Vice Chairman for 2019/20. (NC)
- 1905/81 **Apologies for Absence**

- 1905/82 **Declarations of interests**
Cllr Mrs S Kingdom declared an interest in item 9 (Water Fountain) as the installer is known to her.
- 1905/83 **To agree the agenda as published**
Agreed.
- 1905/84 **Chairman's Announcements**
There were some items for investigating, these included:
 - There is a regular camper at the Quay who transports his belongings from his boat to the Quay by a trolley.
 - The wall at the car park end needs attention.
- 1905/85 **Public Participation**
A number of reports were given by residents at Fremington Quay, these were:
 - Thanks were given to the Council staff for arranging for the fence to be fixed quickly.
 - The Quay Road fence is broken in numerous places and needs attention. Cllr Biederman suggested reporting to Devon County Council.
 - The Footpath with the kissing gate entrance is not large enough to enter with a child's buggy. There is no signage to let walkers know that this is the case.
 - A suggestion of a speed restriction to 20 mph could be sought as there are approximately 600-700 vehicles that enter the Quay on a daily basis. Cllr F Biederman explained that he had reported it to Devon County Council and a report will be going to the next DCC meeting. In addition, Cllr F Biederman showed a photograph of a sign that could be adapted for the Quay Road. This item is to be discussed at the next Fremington Quay Management Committee.
 - The provision of a Muddlebridge bus shelter
 - The Quay Road has overgrown ground vegetation that needs attention.
 - The possibility of applying for a share of an EU Bio-culture and Tourism grant.
 - The overgrowth at the sewage plant.
 - The cutting back of dead trees.

Water Fountain

The Clerk circulated a quotation for the installation of a refillable water fountain at Fremington Quay along with the costs for the actual product. Some concerns were raised by the Café on who will be responsible for the maintenance and the payment of the water. She further reported that £2561 was awarded from the Communities Together Fund and Cllr Cann was successful in his bid on behalf of the Fremington Environment Group.

1. That the GYM Series Outdoor Pedestal Bottle filler with Dog Bowl be purchased.
2. That the quotation of £968.00 be accepted for the installation of the pedestal and water meter.
3. That Fremington Parish Council be responsible for the payment of the water charges for the pedestal.
4. That Fremington Parish Council be responsible for the maintenance of the water pedestal.
