Members were circulated correspondence from home owners on the boundary of Beechfield and that they feel the Parish Council is responsible for repairing the fence. Conditions of Hire

Members were circulated a draft Conditions of Hire for consideration. 1909/23 Climate Emergency/Wild Flower areas

Climate Emergency

Cllr Crawford gave a brief update on the progress to date and that there was due to be a working party meeting on 1st October 2019. The Clerk had invited all interested parties, which stands at 22. Cllr Crawford circulated a draft Terms of Reference for consideration. Cllr Bell circulated the DCC's 10-point plan for Climate Emergency.

The Clerk explained that she had attended the Parish Forum and there was a presentation from the Lead Councillor for Climate Change/Emergency, who informed the attendees that there was a workshop day being planned for 26th October for town and parish councils to attend in order to simultaneously work together rather than each town or parish council tackling the Climate Emergency in silos.

Suggestions from members included a dedicated page on the website, a Facebook page and contacting year 6 students from local schools to help get the message out.

Members were concerned that the draft Terms of Reference were too detailed and that the Council, as a corporate body, had not formally adopted anything other than declaring a Climate Emergency.

Cllr Rennles suggested looking at the Neighbourhood Plan before any formal documents are considered, as there are environmental aspects within and both the Neighbourhood Plan and Climate Emergency Plan should integrate.

Councillors agreed with DCC's 10-point Action Plan and felt this is the first step to tackle with the working party. After discussion, it was **RESOLVED**: That the 10 point plan is looked at, at the first meeting of the working party and gather the members' interests and ideas. That the Clerk writes a basic terms of reference and a full remit and plan of

action is submitted to the November meeting following the workshop day with North Devon Council.
