County and District Councillor reports

Cllr Biederman informed members that the application was refused at Higher Road. The new £800,000 astro turf pitch at Tarka Tennis Centre is due to open at the weekend, it is expected to be used by 1500 people per week and is suitable for many different sports.

Cllr Cann informed members that there is a project well underway to protect the bird life on the Taw Estuary. She further reported that consultations on BT phone box uses were taking place at present and encouraged anyone with suggestions for uses to contact her. She also reported that she will update members when further information becomes available on the 106 monies as there had been a number of requests for information.

Cllr Mackie informed members that she had attended mental health training last week for residents that may approach councillors and found it most useful. There is a Crisis Centre named The Moorings available for self-referral drop ins and open in the evenings. She also informed members that North Devon Council were due to meet with the Fire and Rescue Service to discuss the proposals.

Cllr Mackie also commented on item 12 and explained that she was aware that concerns have already been made to North Devon Council in relation to the Ash beds, who have consequently written to Devon County Council. There was a visit by DCC in July with an Oncologist.

Cllr Walker reported that there is a safety problem with a path that goes straight onto Old Bideford Road from the Glenwood Park development, there is nothing to stop you running straight onto the road. She has requested the Parish Council to take a look and hopefully agree there is a safety issue outside Glenwood Park, then it could be sent to HATOC for discussion and to enquire whether there is any money available. Cllr Biederman referred that it may be a highways issues and he will look into this. Cllr Walker further reported that Fremington Medical Centre has asked for support for a new defibrillator to be sited in its location.

Cllr Capon raised concerns over pavements and road safety at Old Bideford Road. There were discussions regarding the hedgerow at Tews Lane and that there were previous conversations concerning the need for a pavement to the new developments and school, which were originally indicated where the main hedge is situated.

Motion of Councillor Bell – Ash Beds

Cllr Bell reported that Devon County Council designated the site as a wildlife site and that fences were broken down. People who walk over the site have made a track, which has resulted in bike trails being made and nesting birds disappearing. DCC has sent an Oncologist on site and a report was completed.

Cllr Adams queried whether the bike trails were an organised event due to the number of bikes and suggested to word something that could be shared on social media to inform people that this is not an area to be used for trail biking.

Cllr Capon said that he went to a demonstration on Saturday to speak on congestion and traffic management with regards to protecting our estuary. There were 4/5 councillors from different parishes who asked what Fremington Parish Council is doing about the issues.

Members felt that the planning conditions of the fencing should be enforced.

RESOLVED: An amendment to the motion, which resulted in the following motion being approved. That the Council writes to the owners and agents of the Ash beds to voice Fremington Parish Council's opposition to the wildlife site being used for trail biking and to copy in Mr Bowman at Devon County Council and Mr K Bines at North Devon Council and ask North Devon Council and Devon County Council to enforce the planning conditions stipulated.

Climate Change

Cllr Crawford reported to members that he was working on a Terms of Reference and issues that the Council can investigate and complete, which will be submitted to the next Parks and Playing Fields committee.

Cllr Groves reported that he had a number of requests, which may result in financial funding being needed. The Chairman explained that the Council had specific budgets, so a request would need to be made following the Working Party meeting and action plan and that budgetary provisions for 20/21 would also need to be investigated.

1909/13

Fire and Rescue Service

Cllr Biederman explained that the Fire and Rescue Service was consulting on lots of proposals including removing Barnstaple Fire Station from 24 hour to day time cover and retained evening cover.

Cllr Capon stated that given the amount of new housing being built, he finds it unbelievable that the service is looking to be cut. A delay could be detrimental to lives.

Members expressed grave concerns regarding the proposals, and it was **RESOLVED:** That the Council writes to the Devon and Somerset Fire and Rescue Service expressing concerns regarding the cuts to Barnstaple's 24 hour cover and the potential impact on the wider neighbouring towns and parishes.

Councillor questions

Cllr Adams reported that he will be asking the Parks and Playing Fields Committee to start looking at Local Green spaces, infrastructure and local biosphere protection policies.

Cllr Bell asked whether the County and District Councillors attending council meetings could give a written report, rather than verbal.

Cllr Biederman informed members that a group of NCS students planted 50 trees as part of their project. They were kindly donated by St John's Garden Centre. He further reported that Party at the Manor was a great success.

Members raised a concern over the extension to the road to Old School Lane to the Cemetery.

Cllr Capon raised concerns over the Highways Contribution that Fremington Parish Council should have received over the last 4 years. £307,947.20 in Highway contribution should have been received and he requested to know where it has been spent, especially after the Strategy committee last week, where it was noted that S106 contributions have been sought from the Roundswell and Larkbear developments.

He further reported that the Section 106 monies for Openspace at Tews Lane needed chasing up and asked Cllr Cann to investigate this issue with the District Council.

Cllr Groves asked what was happening to the Air Ambulance landing site. The Clerk replied that the Devon Air Ambulance site team had been out to survey the site last week, following the completion of The Beechfield Centre and it is hoped it will be up and running in the very near future.

Cllr Crawford asked for the Fremington Parish Council email addresses to be taken off the website, as they are not working properly.


1909/15 **Part B – Exclusion of Press and Public**
