

Devon County Council (North Devon HATOC) (Traffic Regulation) Amendment Order

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce:

BARNSTAPLE: No Waiting At Any Time on specified lengths of Access to Bowering Court, Castle Street, Cyprus Terrace, Ladies Mile, Orchard Road, Pilton Lawn, Victoria Road and Westaway Heights;

BICKINGTON: No Waiting At Any Time on specified lengths of Bickington Road;

BRAUNTON: No Waiting At Any Time on a specified length of Church Street;

COMBE MARTIN: No Waiting At Any Time on specified lengths of Hillside View, King Street and Wet Lane;

CROYDE: No Waiting At Any Time on specified lengths of Cloutmans Lane;

FREMINGTON: No Waiting At Any Time on specified lengths of Beechfield Road and Yelland Road;

ILFRACOMBE: No Waiting At Any Time on specified lengths of Hillside Road, Horne Park Road, St Brannocks Park Road and St Brannocks Road; **No Loading At Any Time** on a specified length of Mill Head; **No Loading 10am-6pm** on a specified length of St Brannocks Road; **No Loading 10am-4pm between 15 Mar and 31 Oct** on specified lengths of St James Place and The Promenade; **Limited Waiting 10am-6pm 1 Hour No Return Within 1 Hour** on specified lengths of Arcade Road, Fore Street and Hillsborough Road; **Buses Only Max Stay 15 Minutes no Return Within 30 Minutes** on a specified length of Ropery Road;

SOUTH MOLTON: No Waiting At Any Time on specified lengths of East Street;

STICKLEPATH: No Waiting At Any Time on specified lengths of Sticklepath Hill and Wray Avenue;

Where appropriate there will be the usual exemptions including those in relation to the picking up & setting down of passengers, loading/unloading of goods & disabled persons vehicles.

Statement of reasons

The restrictions are being proposed to resolve minor local issues that have been reported to the council and considered as part of the North Devon Highways and Traffic Orders Committee annual local waiting restrictions programme. Specific details of what is proposed at each location can be found within the deposit documents.

The restrictions are proposed to avoiding danger to persons or other traffic using the road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve/improving the amenities of the area through which the roads run.
