2008/01 Apologies

Clirs C Connell, S Adams, K Groves, M Scott and A Rennles. Members were informed that Clir Rennles had requested that his apologies be approved until October 2020 for personal reasons, it was resolved, with no votes to the contrary, to approve the apologies.

2008/02 **Declarations of Interest**

Cllr Cann declared a Personal Interest in Item 2008/17 Application 70941 as the applicant is known to her.

Cllr Biederman declared a Personal Interest in Item 2008/17 Application 71789 as the applicant is known to him and a Personal and Prejudicial Interest in Item 2008/18 Application 71278 as it is his property.

Cllr McCormack-Hole declared a Personal Interest in Item 2008/13.

2008/03 Chairman's Announcements

The Chairman informed Members that a member of staff had been successful in completing the Level 2 Certificate in Principles of Team Leading. Members requested that congratulations be relayed to the staff member.

2008/04 Public Participation Period

None.

2008/05 **County and District Councillors' Reports** - To receive reports from the County Councillor and District Councillors for information only.

Cllr Cann reported that £23,816 had been agreed at the recent resources and strategy meeting for the Babbages Play Area Cllr Cann expressed her delight at securing the money. Cllr Cann informed members that the District Council ward members had received correspondence from the Planning Officer relating to requests to extend working hours in developments. The ward members felt that the times requested (7am – 9pm) were not appropriate in a residential area. There have been recent issues with flytipping and Cllr Cann thanked and congratulated Cllr Walker on continuing to collect and deliver prescriptions to residents. It was noted that the broken fence in Lower Cross Road was being dealt with.

Cllr Biederman reported that the Public Space Protection Order Consultation ends on the 9th August 2020 and urged everyone to respond. Cllr Biederman further reported that the business support scheme ends of the 19th August

2020 and the North Devon Council has paid out over £42 million to 95% of businesses that have applied. A bid has been submitted for £9million to revitalise Barnstaple town centre. The school at Roundswell is progressing well and on scheduled to open in September 2020 and the Enterprise Centre is also progressing well. Cllr Biederman is working with the Police and Community Safety Hub around anti-social behaviour and warning letters are being written to those that have been identified.

Cllr Walker reported that she had submitted a sheet for the planning application 39a John Smale Road to be dealt with by the Planning Committee as it is a repeat application which has been submitted several times. There are applications for proposed tree works at Glenwood Park due to ash die back, however, the tree officer has not yet confirmed if they will be replaced with mature trees.

2008/09 Councillor Advocate for the Police and Crime Commissioner

Cllr Cann informed members that she had stepped down because the meetings were in Exeter and she is unable to get to them, Cllr Hockin had assumed the position but had now resigned from the Council.

Cllr Biederman explained that the meetings are in Plymouth and he is NDC's representative so would be happy to drive Cllr Cann to the meetings if she would like to be the representative.

Cllr Cann confirmed that she would like to resume the position if transport is available and it was **resolved**, with no votes to the contrary, to appoint Cllr Cann as the Parish Council's Cllr Advocate.

2008/10 Plastic Free North Devon

It was **resolved**, with no votes to the contrary, to appoint Cllr Bell as the Parish Council's representative on Plastic Free North Devon.

2008/11 Model Member Code of Conduct Consultation

Members were informed that DALC was encouraging all Town and Parish Councils to respond along with individual Cllrs and members of staff.

Members considered the Model Member Code of Conduct Consultation. Cllr Kingdom raised the point that there is no timescale for the handling of complaints against Cllrs and she felt this was unfair.

Cllr Biederman expressed the importance of Cllrs reading the consultation and the adopted Code of Conduct to refresh themselves of the standards they sign up to as a Cllr and to remember their conduct at all times and especially their conduct towards staff, other Cllrs and when out in the community.

Members spoke in support of raising the lack of time scales for dealing with allegations through the consultation process and felt that this can cause a certain level of distress, especially in a volunteer role. Members did acknowledge that a time scale is likely to depend on the allegation and should be dealt with in the shortest time possible and would like to see reference to this within the Model Code of Conduct.

It was **resolved**, with no votes to the contrary, to respond positively to the consultation and with thanks and express the view that the Parish Council believes complaints should be dealt with in a timely manner and in the shortest time possible.

2008/12 **Bench Policy**

Members considered a draft bench policy for all Parish Council areas excluding Fremington Cemetery. Concerns were raised about the maintenance responsibilities identified within the policy; the Executive Officer explained that once a bench is installed on Parish Council land it does become the responsibility of the Parish Council to ensure it is safe for use. Members discussed the maintenance responsibilities and liabilities further and it was agreed to include within the policy that the Parish Council will make an attempt to contact the owner of the bench if we intend to remove the bench.

Members felt that paragraph 3.12 was contradictory and it was agreed to remove this paragraph.

Page 225

It was **resolved**, with no votes to the contrary, to adopt the draft policy as amended.

Cllr McCormack-Hole declared a Personal Interest in the following item.

2008/13 **Cemetery**

- a) To consider request for Kerb Set
- It was **resolved**, with no votes to the contrary to approve the request.
- b) To consider request for Memorial Bench

It was **resolved**, with no votes to the contrary, to approve the request subject to the location being agreed between the Executive Officer and the Burial Superintendent.

2008/14 Appointments to Committees

- a) To appoint 1 member to the Finance and Personnel Committee
- b) To appoint 1 member to the Footpaths Committee
- c) To appoint 2 members to the Fremington Quay Management Committee
- d) To appoint an Allotment Association Representative

It was noted that 3 members were required to be appointed to the Fremington Quay Management Committee. It was **resolved**, with no votes to the contrary, to appoint Cllr Bell to the Fremington Quay Management Committee and to defer all further appointments until the September meeting and after the co-options.

2008/15 **Community Priorities**

Members were asked to consider updating the Community Priorities for S106 funding. Members were informed that the Committees had identified the following priorities:

Parks & Playing Fields Committee

- Resurfacing and updating all play areas. Members felt the focus should be on improving what we have, not necessarily provision of new.
- Access to Fremington Quay that complies with the Equalities Act 2010 instead of "access to Fremington Quay through development".
- Trim Trail in Fremington.
- Provision of Allotments.

Fremington Quay Management Committee

Enhance the heritage, history and environment of Fremington Quay.

Tews Lane Committee

- Drainage works to the football fields.
- Extension to the community building.

Members felt that the Tews Lane Committee should be asked to consider artificial grass and whether this would be a financially viable option for Tews Lane.

It was **resolved**, with no votes to the contrary, to amend the community priorities as above with the addition of any improvements that reduce the carbon emissions or improve the ecology of the parish.

2008/16 Street Naming

Correspondence was received in relation to the official naming of a new street name for the Roundswell Enterprise Park, the proposed name was:

Enterprise Road, Roundswell Enterprise Park, Barnstaple

Alternatively, the developer had suggested Athelstan Road or Hardstad Road should the parishes prefer. Any suggestions the Parish Council may have for the name of the street were also welcomed.

Members were adamant that Roundswell should be in the name but were content if the Enterprise Centre was to be called Roundswell Enterprise Park it was **resolved**, with no votes to the contrary, to confirm that it will be called Roundswell Enterprise Park and if so the Parish Council supports the road name of Enterprise Road.

2008/17 North Devon Council – Planning Applications

North Devon Council, the determining Authority, has asked for comments from this Parish Council on the following planning applications: It was formally noted that participation of the Councillors who are also members of NDC in both the debate and subsequent vote (in respect of any of the above, were preliminary taking account of the information matters) was on the basis that the views expressed made available at the time to the Parish Council. The District Councillors were reserving their final views on the applications until they were in full possession of all the relevant arguments for and against.

It was **resolved**, with no votes to the contrary, to recommend REFUSAL,

the proposed would constitute over intensification of the site, it is out of the development boundary, the vehicular access over a right of way is not safe and would create a conflict with traffic entering and exiting the site, the proposal does not deliver any affordable homes.

If the North Devon Council is minded to approve all of the homes should be affordable as it is a departure from the Local Plan and proper pavements should also be installed.

Cllr Crawford asked if there was any knowledge of how the parish can access the funding that has been provided to DCC. Cllr Biederman explained that he did circulate details of the funding to all Cllrs and the information is available on DCC's website, however, this funding is very much about urban centres and unlikely to benefit the parish.

Cllr Cann felt that the play area inspections were quite a responsibility and asked if there was anyone else available to undertake the inspections. It was noted that there was not anyone else available at this time.

Cllr Capon asked if NDC had a five-year land supply given the new planning regulations that are being pushed through and the loss of appeal in Torrington.

Cllr Bell asked if there could be an extension on the Public Space Protection Order Consultation as some people have been struggling to access the consultation on NDC's website. It was agreed to email Cllr Biederman.

Cllr Biederman was concerned about the amount of bench applications the Parish Council is receiving for the Cemetery and asked if a Memorial Orchard could be investigated.

2008/21 Riverside Park/Former Army Camp

Members were informed that the solicitor had advised that a lease term of over 7 years would have to be registered with HM Land Registry and would incur additional legal costs for the groups. The Executive Officer had relayed the information to the groups and had asked them to consider the terms carefully in relation to the registration and any implications this could have on funding opportunities. It was noted that originally the Parish Council had agreed to a 10 year term and it was unlikely that this would be long enough for significant funding bids anyway, the Football Club had indicated that they would prefer a 7 year lease and it was therefore **resolved**, with no votes to the contrary, to offer a 7 year lease instead of 10 if the groups were in agreement.
