#### **Environment Fair**

It was noted that invites and posters had been sent out to a list of around 14 companies varying from energy companies, car manufacturers and local health food shops. To date very few replies have been received, some have not responded at all.

**Recommendation**: Administration & Projects Manager to send out reminders to those already contacted. PO is ging to contact Bideford Sustainability Group. MS is still happy to represent allotments and is going to speak to a couple of other allotment owners about them attending the fair, one of whom keeps bees. APM to also contact School again re banner. MS also suggested contacting Bare Necessities.
