I appreciate that some concerns have been raised about parking on the highway but I do not recall any specific issue with construction hours and noise. Previously we have allowed:

1. Construction Work that would not trigger enforcement action may occur as follows:

2. Activities that are very unlikely to cause noise disturbance or other impacts to noise sensitive neighbours including enjoyment of residential gardens in the vicinity.
