2108/04 To approve and sign the minutes of Fremington Parish Council

meeting held on Monday 5th July 2021

It was **resolved**, with no votes to the contrary and one abstention, to approve and sign the minutes of the meeting held on 5th July 2021 as a correct record.

2108/05 County and District Councillors' Reports

> Cllr Cann reported that they had received complaints about the Mead Park development site relating to noise and dust. The District Cllrs had met with the developers to discuss although the impact had been reduced as they were now working further away from existing dwellings. There is an issue with anti-social behaviour in the village which the District Cllrs are pursing along with the highway being used to undertake repairs to vehicles. Cllr Cann reported that Barnstaple Fair will take place this year.

> Cllr Walker reported that there had been issues with assisted and general recycling collections due to COVID-19 and staff having to isolate, if your bin is not collected you are advised to leave out for 48 hours, if there are not high winds, and a crew will endeavour to collect during that time. Roundswell Residents had written to District Cllrs about the path between Coopers Close and the industrial estate, the brambles are growing over the pathway. This has been reported to DCC, however, they have been informed that it cannot be cut back until 1st September due to nesting birds.

Cllr Mackie reported that she had signed people to report a similar issue with the path from Welches Lane to the Instow turn off, the brambles from the field are growing over the path. NDC is preparing a levelling up bid which is aimed at helping areas and in particular town centres regenerate, the bid will be for Ilfracombe Town Centre. The way in which possible breaches of planning compliance is reported has changed and there is now an online form for everyone to complete. NDC had training last week on cyber security and crime and Cllr Mackie will forward the details onto the Parish Council. Cllr Mackie has been asked several times when the link between Tarka Ridge and the Tarka Trail will be opened, the developer is currently waiting adoption checks from Devon County Council.

A copy of the updated Rules and Regulations for Fremington Cemetery were circulated prior to the meeting, and it was **resolved**, with no votes to the contrary, to adopt the updated Rules and Regulations.

The Chairman proposed and it was unanimously agreed to suspend Standing Orders to allow a member of the North Devon Public Transport Users Group to make representations on items 2108/08 and 2108/09.

The member of the North Devon Public Transport Users Group addressed the Council and explained that the urgency of global warming is what any plan should be centred around, we should encourage people to use public transport as much as possible, however, connections need to link and we need to look at the whole network and existing road system.

Cllr Mackie left the meeting.

The rail and bus services have to link and service the whole area including rural communities, there has to be integration and good connectivity. The Parish Council and other authorities need to be putting pressure on the bus companies and DCC to ensure integration takes place.

It was unanimously agreed to reinstate Standing Orders.

Cllr McCormack-Hole – how long do we have to continue with COVID restrictions? It was noted that although government restrictions had been lifted it was up to individuals and organisations to continue to act responsibly, it was noted that transmission rates were at their highest in North Devon and members felt a cautious approach should be taken.
