2111/16 County and District Councillors' Reports

Cllr Biederman had attended a Housing Crisis Forum recently, attended by Stakeholders, NDC, Torridge, North Devon Homes and Perrigo to discuss the dire need for housing in North Devon. Notice to quit from landlords with tenants in rented accommodation is now at two months and is causing a lot of problems. Affordable homes are desperately needed. There is a Carers shortage, they are desperately needed as are Foster Parents. He has been trying to push through 20mph speed limits and this has been pushed back, however, a trial is being carried out in Newton Abbot.

Cllr Cann and Cllr Walker attended a meeting on the Housing Crisis, a meeting will be arranged with parliamentarians. They are currently sorting out car parking at the North Lane development, the road will then be adopted. The car park at Fremington Quay is not closed, the sign was put there by person(s) unknown and taken from Bickington Road where SWW is currently working but has now been removed.

2111/17 Police

No report had been received from the Police and there was no attendance at the meeting.

A response to the letter sent to the Police & Crime Commissioner regarding concerns on the subject of difficulties in answering of 101 and 999 calls was distributed to Cllrs and was noted. Cllr Walker advised that members of the public should report any difficulties that occur.

2111/18 Leave of Absence Requests

Cllrs considered the leave of absence requests from Cllr Scott and Cllr Goodger and it was **resolved**, with no votes to the contrary, to grant leave of absence, to be reviewed in January 2022.

Clirs requested that a letter be sent to DALC with concerns about Clirs attendance at meetings, in particular with regard to Covid.

2111/19 Parks & Open Spaces Committee

It was **resolved**, with no votes to the contrary, to appoint Cllr Walker to the Parks & Open Spaces Committee. Cllr Steer had resigned from the Committee as he was unable to attend meetings due to the timing of the meetings and his work commitments.

2111/20 Multi Use Games Area (MUGA) Riverside Park

Cllrs discussed the further information received from the developer regarding the carpet and the 7 year warranty/clean MOT offered by Barratts.

Cllr Biederman gave a brief overview of the history surrounding the facility and outlined the expense of maintaining the carpet. He explained that it had been agreed at a meeting with the developer, North Devon Council and Residents' Association that, if the facility was free to use, the PC did not have to maintain the carpet and could remove at the end of its natural life, make good the tarmac underneath and line, the cost of which was estimated to be in the region of £20,000 and Cllr Biederman proposed that a budget of £1,000 be included each year towards this cost.

It was noted that the proposal not to maintain the carpet would negate any warranty offered by the developer and that the costings involved in making the tarmac good in the future could increase, however, the carpet was worth around £20,000 and it was felt that it would be better to use it until it reaches the end of its natural life instead of removing straight away.

Cllr Connell asked for clarification on the use of the floodlights it was confirmed that these would be turned off and not in use.

Following lengthy discussion Cllr Biederman proposed, seconded by Cllr Cann that:

SX

- 1. The Parish Council adopts the MUGA subject to the developer paying the sum of £15,429.70 to the Parish Council as agreed.
- 2. That, as this will be a free to use facility, once the carpet reaches the end of its natural life it is taken away and the maintenance contribution is used to make good the tarmac and line the surface.

When put to the vote it was **resolved**, with 2 abstentions and 1 against, to adopt the MUGA on the understanding that the developer pays the sum of £15,429.70 to the Parish Council as agreed and to take away the carpet once it has reached the end of its natural life and make good the tarmac and line the surface.

 Cllr Biederman suggested that it would be nice for the Parish Council to arrange a celebration event to mark the Jubilee and suggested that a working party be set up to include local residents' associations, clubs and local schools in the Parish. Cllrs Biederman, McCormack-Hole and Cann undertook to arrange a date to meet and discuss the arrangements for the celebration.
