2112/07 County and District Councillors' Reports

Cllr Biederman reported that a consultation is to take place on signalisation of the junction at Cedars in the rush hours to improve flow of traffic through Bickington, past the Cedars roundabout. The Modelling showed that it would improve journey times from Fremington direction by 10-15 minutes, it also showed that it improved journey times from Roundswell direction by 2 minutes, this was following the trial in 2019 taken over two weeks using cameras.

He had a meeting with DCC, NDC & senior people from Redrow to sort the dangerous crossing at the Roundabout of Tews Lane and the Redrow Development. It was agreed to remove the top of the hedge, to give visibility for 40m. The developer would be planting trees in another location to match the biodiversity loss.

The HATOC Committee considered an item on moving the Bus gate into Old Torrington Road, meaning all traffic entering or leaving the area past the Crematorium, including the new development at Larkbear, would have to use Howard Avenue through the old Bus gate. Councillor Joy Cann and I raised severe concerns on the impact of this on the already congested Cedars & Roundswell Roundabouts. A proposal by me to leave traffic to find their shortest most convenient route was lost but a compromise of allowing traffic to go one way through the Bus gate from Old Torrington Road was passed. This will be reviewed after one year of operation.

Clirs Walker and Cann have registered for Speedwatch and hope to have a team in place by Spring.

They attended the special Policy and Development Committee meeting regarding the housing crisis and a 10 point plan has been put forward to the Committee on the 9th December for discussion.

The purchase of Green Lanes has been completed following a unanimous vote to buy it. This will add to the regeneration already planned and funded from the Future High Street Fund. Money is in place to repair and improve the building, this will protect the main shopping centre in North Devon from becoming run down and neglected. This has been funded by a low cost government loan, which will be more than covered by income from the centre.

North Devon Crematorium will be making an award of £15,000 to the Fern Centre from the ICCM metals recycling scheme, through the Over and Above hospital charity. This is the biggest award made.

The Cedars roundabout has been tidied up by North Devon Council employees, which is a great improvement, particular thanks go to Chris Williams from Waste & Recycling for getting it done at 5.00am to make sure it did not hold up traffic.

On Monday 13th December the North Devon Environment Officers are holding a Talking Rubbish! Morning from 10am-12pm at Sticklepath Methodist Church Hall for any community litter pickers to gain views on what is happening with litter picking. Tea and Cakes provided.

CIIr Cann reported that she sits on the Licensing Committee and asked that the agenda and graphs on Crime rates be placed on the Members site for CIIrs information.

In District Cllr Mackie's absence from the meeting, the Chairman read out her report which is attached as Appendix A.

Members were circulated the draft budgets for 2022-23 and Recommendations report by the Executive Officer prior to the meeting. It was **resolved**, with no votes to the contrary, that the Council's initial Precept Request be submitted to North Devon Council for £276,488.92.

Members considered the draft of the proposed Declaration prepared by Cllrs Walker and Cann. Members felt that some points needed to be amended and further comments were required. Cllr Biederman stated that the Declaration should be included in the Neighbourhood Plan. It was agreed that any further comments should be forwarded to the Executive Officer by Wednesday 15th December 2021 for onward transmission to Cllrs Walker and Cann. The amended Declaration will then be placed on the agenda for a Full Council Meeting for a final decision.

She felt that there was a need to establish the time of the last bus. Cllr Biederman to be copied into the letter.
