The Parish Council has moved from Zoom meetings to live attendance meetings which has caused some consternation as some Councillors have been exposed to Covid and therefore they have not been able to attend. We did appeal to the Government along with other Councils to be able to carry on with Zoom meetings but the Government rejected the appeals and said that there was not enough legislation time to enable this to continue. Members of the public can now attend the meetings in person.

As a result of Covid we are looking at our energy bills more closely and would suggest that you do the same. I personally had my supplier stop trading and I am now faced with substantially higher bills. This has probably happened to a lot of you and is not a comfortable situation.

The Planning Appeal for the Yelland Power Station site has recently finished. It happened over six days which included a site visit. A great many people spoke passionately over their fears for the site. We now have to wait for the Inspector's decision which I understand will take two months.

The situation in Ukraine has not helped, we have the country in our thoughts and hope the situation doesn't get out of hand.

The Executive Officer commenced her maternity leave on the 6th August 2021 and had a baby boy on the 8th August. All is well with both mother and baby.

Mrs Eileen Badcock came out of retirement in August to cover maternity leave for Victoria Woodhouse and will leave the Council in August 2022 following Victoria's return to work.

Mrs Jude Wood successfully completed her probationary period as Projects and Administration Manager in September 202. She has proved to be a great asset to the Council and looks forward to a good year in 2022-2023.

Miss Nieve Wuttke-Keary, Administration Apprentice, passed the first of her exams at Petroc and has two further exams to complete. We wish her every success in passing these also.

As reported in the Annual Report for 2020-21, an allocation of £30,000 that year has this year seen the replacement of Multi-Use Play Equipment at Babbages and Mulberry Play Areas and new wetpour at the Galleon at Fremington Quay.

I am pleased to say that the Committee has once again awarded around £2,400 to local groups to include a grant to the Records Office, which will be awarded in July 2022. It is hoped that more local groups will apply for a grant next year.

I would like to thank the members of the Committee and staff for the support they have given me over the year.

FREMINGTON QUAY MANAGEMENT COMMITTEE



As Chairman of this Committee for only one meeting my report will be brief.

My meeting dealt mostly with the Fremington Quay Environment Group and the proposed improvements to the Heritage Centre. This would include re-painting the Signal Box Tower and changing its colour, repairing the Tower Signal Boxes, proposed new signage for the Signal Box Tower, all in original railway colours. Fremington Parish Council has agreed to contribute £1,300 towards the cost of redecoration and repairs.

The Environment Group also proposed large changes to the content of the Heritage Centre, this would include audio visual kiosks enabling visitors to experience the history of the Quay on screens. In addition, a large Smart television would be placed on the end wall which will have four or five short videos that visitors can select for themselves.

Details of the proposed new layout for the Heritage Centre can be viewed on Appendix One of the minutes of the Fremington Quay Management Committee meeting held on Thursday 31st March 2022.

TEWS LANE COMMITTEE

I was elected as Chair of this Committee on the 30th of September 2021 taking over from Cllr Sue Kingdom.

Since that date three meetings have taken place and I am pleased to say that committees are now returning to face-to-face meetings after Covid19 restrictions were eased. I have chaired each of these meetings.

As we resume to normality, the usage of the facilities at Tews Lane has increased. This is very positive and hopefully will continue.

The Committee, along with the assistance of the Parish Council's Project & Administration Manager, Jude Wood, has dealt with several issues.

The installation of an access gate and footpath caused many problems. After several e-mails being sent to the developers it has now been addressed and as a Committee we are now able to report that issues have been dealt with satisfactorily.

There have been discussions around the extension of the Tews Lane Pavilion, this is still a work in progress and I am pleased to say it is moving forward in a positive way. Extra finances will still be required but Committee will look further into other avenues of funding to enable completion of the project.

Pitch drainage has been an issue for many years and one which limits the use of the site. Members were informed that S106 funding from a local development could be used to address this problem. Hopefully, in the future with this work being carried out, a greater part of the pitch will be fit for purpose.

It has been agreed after designs/quotes were viewed what type of Multi-Use Games Area (MUGA) is to be installed at the site along with 2 pathways adjacent to the MUGA area.

If any member of the public requires a more detailed account of above, it can be sourced from minutes of previous meetings. These minutes will also include the discussions around proposed spending and approximate costs.

PARKS & OPEN SPACES COMMITTEE

Last year we were lucky enough to be able to update the play equipment at Babbages and Mulberry Play Areas. We were very grateful to have the opportunity to do this and hope to identify similar funding in order to rejuvenate the Ellerslie Play Area.

Additionally, we have replaced the wetpour under the galleon play area at Fremington Quay along with removal of the damaged wooden slats on the rope bridge and replacing it with a cargo net style bridge. We are confident that these items will enhance the area.

The Parish Council has also planted a selection of Mixed Hedging Hawthorn Base Saplings behind the dugouts in Beechfield Playing Field. We are grateful to have received a grant that allowed us to do this and look forward to seeing them grow in the years to come.

Griggs Field has been cut and the drainage ditch has been cleared. The path that was laid around the field appears to be holding up well and will see some maintenance as winter nears.

Both Nature Reserves within Fremington Leat Meadow and Lovells Field have seen volunteers from within the community along with guidance from representatives from North Devon Council carrying out management work on the land to maintain it.
