4 To discuss matters raised by parishioners

Mr Biederman spoke as a parishioner. He wondered whether, given the current situation in Ukraine, a flag should be purchased by the Parish Council to fly on the Parish Council's flagpole. Cllr Kingdom thought it was a sound idea and all Cllrs agreed.

Mr Binns stated that although our Government's reaction at the moment is extremely niggardly, we are going to experience the largest population displacement in any of our lifetime but I expect the situation to change radically over the next weeks. Should we be considering village halls and other assets as



places that might have a creative response as to what is going to happen. Cllr Kingdom said that we will have to wait to see what happens. Generally, the Government contacts all councils in the country and asks how many people they can take and in the situation for Afghanistan I believe we took five families, so we may not have an influx but we may do. I think we have to wait until we hear more but North Devon Council, I believe at the moment, is on top of it. Mr Biederman, speaking as a County Councillor, advised that obviously Devon County Council as the lead authority takes the lead with District Councils as, certainly in the Afghanistan and Syrian situations, they know who in our community to ask what facilities are available and it will be interesting to see what happens.
