2304/11 **Declarations of Interest**

Cllr Biederman and Walker stated that participation of the Councillors who are also members of NDC in both the debate and subsequent vote (in respect of any of the planning applications) was on the basis that the views expressed were based on the information made available at the time to the Parish Council. The District Councillors were reserving their final views on the application until they were in full possession of all the relevant arguments for and against.

2304/12 Chairman's Announcements

The Chairman thanked Parish Cllrs for their contributions over the last four years.

2304/13 Public Participation Period

Members of the public raised concerns in relation to application 76796 due to the loss of wildlife including protected species, farmland, the important buffer between the village and estuary setting, the alteration to the character of the area, the noise and light pollution that would be created and the lack of infrastructure including oversubscribed Drs surgeries, hospital, schools and road network. The proposal is in a flood zone and concerns were raised about the capacity of sewage treatment plants, the discharge of these and flooding caused when over capacity and water treatment plants. The development was felt not to be sustainable and a loss of habitat and grade 3A agricultural land and not a viable option, it was noted that new houses are required but this is not the right place for development. Members of the public questioned why brown field sites are not being developed above green spaces, this development was felt to be contrary to policies in the adopted Neighbourhood Plan and would open the whole estuary up to development.

It was proposed and unanimously agreed to move Item 13 application 76796 on the Agenda forward to this point.

76796 Proposal: Residential development comprising of 101 homes, infrastructure including access works & associated open space

Location: Chilpark, Fremington, Devon

Applicant/Agent: Pearce Construction (Barnstaple) Ltd

It was **resolved**, with no votes to the contrary, to recommend REFUSAL for the following reasons:

The proposal is outside of the adopted Local Plan.

The proposal is not sustainable, there is not the infrastructure to support the development and in particular a lack of health and social care, education, sewage and road network.

The proposal is within flood zones 2 & 3.

The land is grade 3A best and most versatile agricultural land.

There would be a severe loss of biodiversity.

The proposal would be an encroachment on the estuary and open countryside setting.

The Parish Council has concerns over the safety of people using the permissive footpath.

Amenity considerations - there would be an adverse impact on the amenity of neighbouring properties.

It was further **resolved**, with no votes to the contrary, for the Parish Council commission an ecology survey it was noted that landowner permission would need to be sought.

Members received a response from NDC with reference to the HELAA and the Parish Council's concerns about the lack of Parish Council representatives on the panel. It was noted that "the number of panel members is deliberately limited to ensure it can operate efficiently and effectively."

It was **resolved**, with no votes to the contrary, to accept and note the response and to write to the North Devon Council to request that the HELAA is delivered swiftly and state that the Parish Council feels that a new village/town is required with appropriate services and good connectivity to public transport links rather than "pepper potting" housing developments around the existing.

2304/22 Councillors Questions

Cllr Biederman asked if the Parish Council would write to Cllr Mackie and thank her for her support over the last few years. It was agreed to write to Cllr Mackie.

Cllr Cann thanked the Chairman of the Council, staff and Cllrs for their support over the last four years.

Cllr Walker echoed Cllr Cann's statement.

Cllr Steer explained that he had accepted a new job as the Town Centre Ranger in Barnstaple.

Cllr McCormack-Hole asked for the issue of the lack of pharmacies and pharmacists in the area to be raised, she explained that the pharmacy in Sainsburys is closing and the lack of services will put further strain on A & E and Dr surgeries.

Cllrs Rennles, Connell and Scott also echoed Cllr Cann's sentiments.
