County and District Councillors' Reports

Cllr Norman introduced himself and explained that there is a consultation available through DCC on a new bus lane in Roundswell.

Cllr Walker/Cann

Cllr Walker reported that members had met NDC's Park Officer to consider the placement of 3 trees as part of the planting reprogramme following the felling of trees along the road from Cedars to Sainsbury's. It was agreed that they would be planted between Scout Hut and gate, contractor will maintain for two years after which they will become the responsibility of NDC. The Planning Application for the Scout Hut at Ellerslie has been submitted.

Cllr Biederman reported that there is a technical application relating to Yelland Quay for the discharge of conditions and they have to confirm how they are going to protect the trees as part of the conditions, the NDC officer has confirmed, following a site visit, that no works to trees have commenced as part of the planning application and won't until this condition is discharged.

There is a DCC consultation on creating a bus lane from the Sainsbury's roundabout towards the Roundswell roundabout onto the A39 and he would question how many buses would use the lane and raised concerns about the length of a queue that would be caused as a result which buses would have to also sit in prior to reaching the bus lane. Cllr Biederman urged Cllrs to submit individual representations, members were not supportive of a bus lane in this area, and it was agreed for the Executive Officer and Chairman to submit a response on behalf of the Parish Council to raise these concerns.

Councillors Questions

Cllr Bell explained that he was raising concerns about the felling of the two clumps of trees around the back of the Power Station, he does not see why they should be removed and felt it should be looked at.

Cllr Cann asked if the consultation on the bus lane could be placed on the Parish Council's Facebook page.

Cllr McCormack-Hole asked if members were aware of the possible closure of the link centres, it was noted that this was in consultation stage and had been reported at a meeting previously. Cllr McCormack-Hole felt that Cllrs should get to know each other and the organisations they are involved with.

Cllr Biederman explained that the Inspector had passed the planning approval for Yelland Quay which details exactly which trees will stay and which will be removed, there is a replanting programme as part of the conditions on a two for one basis.

There being no further business the meeting closed at 7.30pm.
