

Update on Climate Emergency

This issue is mostly about the Parish Council's commitment to addressing the Climate Emergency that was declared by Fremington Parish Council in 2019 and improving the environment for the community. The Environment and Community Committee has recently reviewed the Action Plan that was adopted following the declaration, the updated plan can be found on the Parish Council's website.

The Parish Council has also taken the decision to ban Chinese lanterns and disposal BBQs on its land to help our wildlife and environment.

Reduce Single Use Plastic

The Parish Council is committed to reducing its single use plastic and has also made a conscious decision to replace products such as washing up liquid, surface spray, clothes and

sponges for environmentally friendly alternatives. We are also encouraging our hirers and users of our facilities to reduce their single use plastic and to use re-useable alternatives wherever possible.




Upgrade to Play Areas

The Parish Council has recently appointed Wicksteed to carry out upgrades to the Beechfield and Ellerslie Road Play Areas. We are just in the process of securing the Section 106



funding from the District Council and we hope these works will commence in early September.
