Cllr Walker confirmed that the company that built the estate has gone into administration and the open space has not been transferred to the North Devon Council as it should have been, North Devon Council does not wish to consider building on public open spaces and is pursuing the legal paperwork to ensure the land is transferred and remains as public open space.

## **County and District Councillors' Reports**

Cllr Biederman - Fremington Ward

Cllr Biederman reported that Footpath 33 has been closed due to vandalism to the safety barrier and will remain closed until repairs have been completed, Cllr Biederman asked if anyone has information on the criminal damage to let him know.

## Cllr Walker/Cann - Bickington Ward

Cllr Walker reported that the Strategy and Resources Committee has agreed the Section 106 funds for the upgrades to the Ellerslie Road and Beechfield Play Areas and thanked Mr Kentell for his assistance in securing. A community lottery is being set up for North Devon where small local groups can be supported. There was a question if Houses in Multi-Occupancy would be allowed to let rooms as holiday homes, there is a consultation which will seek to say no to the request. The Street Marshalls scheme has been extended for another six months and split between Barnstaple and Ilfracombe. The new Changing Places facility has now opened in Green Lanes and there is a consultation out for a review of Public Space Protection Orders.

## Cllr Denton – Fremington Ward

Cllr Denton reported that a planning application has been submitted for a further 210 houses on the fields at Yelland Quay which the District Cllrs have called in to the planning committee and will be meeting with the Planning Officer next week to go through the details.

#### Cllr Norman - Roundswell Ward

Cllr Norman reported that the bus gate on the Old Torrington Road is now in situ, however, the enforcement is not yet, phase one of the new development is nearing completion and phase two has already been agreed but there is a slight change in numbers.

## Cllr Biederman - Fremington Ward

Cllr Biederman confirmed that, following a statement at the last meeting from a Cllr that the drains in Chilpark had been cleared for five years, they had been checked and cleared in 2020 and again in June 2023 and the Officer is happy that they are all clear and working.

Cllr Bell asked about the Power Station Road in Yelland, there are conditions that require certain items to be in place prior to development, such as a car park for the Tarka Trail, and these are not shown on the new planning application for development.
