After discussion it was also agreed to review the grants process.

# 2311/47 Budgets and Precept

The draft budgets were circulated prior to the meeting. It was noted that running costs had increased significantly especially insurance costs, members were informed that the insurance cost was likely to be more than the figure shown in the draft budgets as the van insurance had increased by almost £1,000 this year. It was noted that items such as software ad utilities had increased and there was likely to be an increase in contracts for services such as dog bin emptying, Legionella, it was also noted that the lease for the Muddlebridge allotments is due for renewal at the end of March and although an increase in rent was likely the amount was unknown. The budgets also provided for an increase in the Parish Council's services.

Members were informed that the Tews Lane Committee had decided not to proceed with the community building but would require an EMR for project costs to secure the S106 funding and had asked for £15,000 to be placed in an EMR if available from savings at the end of the financial year.

Members reviewed the Parish Council's reserves, it was noted that the Parish Council's net expenditure is approximately £30,000 a month, the JPAG (Joint Panel on Accountability and Governance) Practitioners' Guide 2023 states that generally the appropriate level of reserves should be between 3 and 12 months expenditure. Members noted that there was currently £50,000 in a minimum reserve and £25,000 in general

reserves and this would be reviewed along with Ear Marked Reserves at the end of the year.

Based on the draft budgets the recommended precept was £304,888 which based on a Band D Property and last year's tax base is an annual increase of £5.

It was **resolved**, with no votes to the contrary, to accept the budgets and to recommend to Full Council that the precept for 2024/2025 is set at £304,888.

# 2311/49 Staffing Matters
