2406/33 Climate Emergency – Update

Cllr Dixon reported that The Copernicus Clime Change Service (EU) stated that April 2024 had the worst ever global average surface air temperature 1.58 degrees warmer than the April average of 1850 to 1900 and at the UK Climate Change Committee in March 2024 Baroness Brown, Chair of the Adaptation Committee stated that the "UKs current approach to adaptation is not working".

It was agreed that more needs to be done to tackle climate change which should come from the top down, however, the only way to achieve change might be by placing pressure from the bottom up and it was agreed to place an article in the newsletter and on Facebook.

2406/34 Safety of Lithium-ion Batteries and E-bikes and Scooters

Members had received a request to support a campaign to improve the safety of Lithium-ion batters and their use in e-bikes and scooters. Cllr Walker expressed that there had been some heartbreaking stories in the news, and they should be disposed of safely to prevent fires and the injuries and fatalities that have happened as a result of unregulated batteries. It was noted that there is a disposal facility for them at the Brynsworthy Environment Centre, but loose batteries should not be placed in the recycling boxes, however, they can be left in a small electronic device which can be bagged and placed on top of the recycling box, it was agreed to place an article in the newsletter and on Facebook. Members considered the request, and it was **resolved**, with no votes to the contrary, to support the campaign.
