Cllr Walker/Cann - Bickington Ward

Cllr Cann reported that NDC had held a Full Council meeting to discuss the devolution proposals, and it was agreed to support the 1:4:5 model, it was noted that Exeter and Plymouth are economic drivers for Devon.

Cllr Walker reported that there is an underspend in the household support fund and these will go to the North Devon Food Bank for fuel for those most in need.

Cllr Biederman – Fremington Ward and Devon County Council

Cllr Biederman reported that the planning application for Chilpark will be presented to North Devon Council's planning committee at its May meeting for discussion.

#### 2504/16 **Section 106 Priority List**

Members considered the Parish Council's priority list for Section 106 Funding. Cllr Biederman felt that there was a lot on the list for Bickington and raised concerns that this could affect projects being delivered. Members discussed and debated the priorities for Bickington, it was noted that the completion of the pavilion at Tews Lane is in the process and has the required funds, Cllrs Walker and Cann, as ward members, agreed that the main priorities for Bickington are the Scout Hut, Tomlin Hall and the drainage at Tews Lane. It was noted that there was around £60K available for the Scout Hut at Ellerslie and NDC is in the process of transferring the freehold of the land to the Scouts so that the group can attract grant funding, therefore, it was agreed to allocate this to the project as a substantial starting point for the group and remove from the list.

After much discussion it was **resolved**, with no votes to the contrary, to amend the lists as follows:

##### **Yelland – no change**

- Littlemoor Green Project (NDC)
- Play Area and Access
- Purchase of land for community building/man shed

##### **Fremington**

- Resurfacing of play area (wetpour) – remove
- Enhancement of existing play areas
- Trim Trail – remove
- Provision of allotments – remove
- Any improvements that reduce carbon emissions or improve the ecology of the parish

## Bickington

- Scout Hut Ellerslie Road – allocate the funds available and remove.
- Play Area – Equipment Ellerslie Road – remove
- Extension to building to provide storage and function room as well as community car park Tews Lane – remove
- Drainage for football pitches Tews Lane – top priority along with improvements to Tomlin Hall
- Improvements to Tomlin Hall – top priority along with drainage for football pitches
- Improvements to changing rooms Tews Lane – remove
- Enhancements of play area Tews Lane
- Improvements to Babbages play area

### Councillors Questions

Cllr Biederman thanked the Maintenance and Amenities Operative for his assistance with the community spruce.

Cllr Harris asked why the Aspen Grove play area is fenced off, it was noted this was NDC and would be followed up with the District Cllr.

Cllr Cann raised concerns about two street lights in Bickington which are blocked by trees from a house, it was noted that this would need to be reported to DCC.

Cllr McCormack-Hole thanked everyone for their support in her retirement and asked what is happening with the former Civic Centre site. It was noted that the site had been purchased but believed the company has gone bankrupt.

Cllr Smlatic asked if the Parish Council was aware that Fremington Manor was closing and what its future use might be. It was noted that members were aware it was closing but did not have any knowledge of future use, however, it is listed and in a Conservation Area.

Cllr Kingdom thanked Cllr McCormack-Hole for everything she had done on behalf of the community.

There being no further business the meeting closed at 8.20pm.
