#### 2505/14 **Review of Financial Regulations**

Financial Regulations were reviewed, and it was **resolved**, with no votes to the contrary, to alter Financial Regulations following changes in legislation and amended model Financial Regulations from NALC and as follows:

11 Contracts (Pg11 onwards) to read:

b) Where it is intended to enter into a contract:

i) exceeding **£3,000** but less than £60,000 in value for the supply of goods or materials or for the execution of works or specialist services other than such goods, materials, works or specialist services as are excepted as set out in paragraph (a) the Executive Officer or duly authorised Deputy shall invite quotations from at least three firms, due diligence should be undertaken on each firm.

# ii) For contracts estimated to be over £30,000 including VAT, the council must comply with the requirements of the Legislation regarding the publication of invitations and notices.

iii) For expenditures of **£3,000** or less in value the Executive Officer or duly authorised Deputy shall have executive power subject to budgetary provision.

11.2 Any proposed contract for the supply of goods, materials, services and the execution of works with an estimated value in excess of £60,000

shall be procured on the basis of a formal tender as summarised in Financial Regulations below.

Any formal tender process shall comprise the following steps:

i) a public notice of intention to place a contract to be placed in a local newspaper;

ii) a specification of the goods, materials, services and the execution of works shall be drawn up;

iii) tenders are to be sent, in a sealed marked envelope, to the Proper Officer by a stated date and time;

iv) tenders submitted are to be opened, after the stated closing date and time, by the Proper Officer and at least one member of the Council;

v) tenders are then to be assessed and reported to the appropriate meeting of Council or Committee.

Neither the Council, nor any committee, is bound to accept the lowest tender, estimate or quote.

For a contract for the supply of goods, services or works where the estimated value will exceed the thresholds set by Parliament, the full requirements of The Procurement Act 2023 and the Procurement Regulations 2024 or any superseding legislation ("the Legislation"), must be followed in respect of the tendering, award and notification of the contract.

Members discussed the application and acknowledged that affordable housing is needed, and the proposal would also take the pressure away from the B3233.

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to the development providing a minimum of 30% affordable housing.

## 2505/20 **Councillors Questions**

Cllr Cann asked what action the Parish Council could take against the emails being received in regard to "fake news", Cllrs have found them rude and bordering on hate crime and racist. Cllr Can felt that the Clerk's response to the emails to date had been "superb" and confirmed support for the statements released by Cllr Biederman and the MP. Members were advised that the Parish Council does have an adopted Unreasonably Persistent and

Unreasonable Customer Behaviour Policy and Guidelines, support from the office to implement the policy should be sought, if it is borderline the sender

should be given the opportunity to moderate their language and behaviour, if it is clearly a hate crime/racist this should be reported to the Police.
