

**Minutes of the Planning Committee Meeting

2505/32 **Apologies**
None.

2505/33 **Declaration of interests**
Cllr Tamlin declared a Persona Interest in Item no 2505/36 planning application 80162 as a neighbouring property.

2505/34 **Public Participation Period**
A member of the public spoke in relation to application 80162 and raised concerns about the considerable amount of development on the site. There has been a lot of noise and disruption over the past two years. The member of the public raised concerns that the applicants were taking advantage of the planning regulations. They explained that there had been an increase in traffic, which poses a danger to members of the public and horses using the footpath. The plan submitted showing the entrance is inaccurate there has been an encroachment of DCC land. The member of the public stated that they are also aware of more plans for another barn which they feel will be converted to another house in another five years and expressed that the lane cannot cope.

Another member of the public also raised concerns in relation to the planning application. They stated that the applicants have taken away screening, removing mature trees on Devon highways land. The member of the public runs a camping business and its 'unique selling proposition' for the campsite is that it is quiet and secluded. The campsite was unable to open last year due to the noise from the development, resulting in a loss of income, the farm is a working farm and is the only source of income. Concerns were also raised over the safety of users of the lane. Verges have been removed and now cars are parking where the verge was causing obstructions with large vehicles, such as the farms feed delivery lorry, unable to get up the lane.

Another member of the public explained that they had previously lived at Great Knightacott for many years around 1990. The area was always quiet back then. Now, when they visit, they often encounter approaching vehicles. They feel that the recent development is very disappointing.

- 80207 Proposal: Notice of an application to modify a planning obligation under regulation 3 of the T and C P (modification & discharge of planning obligations) Regulations 1992 in respect of sub clause (iii) of sub-clause (h) of Clause 5.1.1 (53147)
Location: Former Fremington Army Camp, Hill Top, Fremington, EX31 3BJ
Applicant/Agent: LiveWest Homes Limited

It was **resolved**, with no votes to the contrary, to make no comment. It was felt that a clearer explanation of the modification to the S106 was needed. There was concern that this change could impact on the future of social housing.

- 80242 Proposal: Application for consent for works to trees covered by a Tree Preservation Order in respect of crown lifting and crown reduction of 1 x Beech tree
Location: 11 Shieling Road, Bickington, Barnstaple, EX31 2LY
Applicant/Agent: Mr Kidd

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to the proposal being in the interest of good tree management and no impact on neighbouring properties.

Delay of Infrastructure


The response from the Ministry of Housing, Communities and Local Government was noted.
