It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the meeting held on Thursday 22<sup>nd</sup> May 2025 as a correct record.

**2506/34 North Devon Council - Planning Applications**

80305 Proposal: Application for consent for works to trees covered by a tree preservation order in respect if additional works to tree specified in previous application 79935 for crown reduction to X1 Mature Ash  
Location: 77 Lagoon View, West Yelland, Barnstaple, EX31 3LE  
Applicant/Agent: Suber Ltd

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to the works being carried out after the nesting season.

80309 Proposal: Variation of condition 2 (approved plans) attached to planning permission 79369 (Alterations and extension to existing property to include conversion of studio outbuilding into living room accommodation) to allow removal of chimney and amendments to fenestration

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to the approval of the Heritage & Conservation Officer

80365 Proposal: Reserved matters application for 20 detached dwellings and social hub (café and cycle hire facilities) pursuant of application 60823  
Location: Former Yelland Power Station, Lower Yelland, EX31 3EZ  
Applicant/Agent: Yelland Quay Ltd

It was **resolved**, with no votes to the contrary, to recommend APPROVAL

- 80375 Proposal: Change of Use of Class E(b) to permit the sale of food and drink and creation of café and children indoor play business

It was **resolved**, with no votes to the contrary to recommend approval but to make the Planning Officer aware that there was concern over the lack of parking within the area.

- 80385 Proposal: Refurbishment, rearrangement and new-build extension to an existing commercial building. No change of use – building remains use class B2 general industrial and B8 storage or distribution.

It was **resolved**, with no votes to the contrary, to recommend REFUSAL. The developments flat roof is not in keeping with the area and it is outside the development boundary. Members were also concerned that Combrew Lane is very narrow and that the access is not sufficient.

It was **resolved**, with no votes to the contrary, to recommend APPROVAL, subject to the amenity of the neighbouring properties.

80456 Proposal: First floor extension above garage  
Location: High View, Pottery Lane, Yelland, EX31 3EH

It was **resolved**, with no votes to the contrary, to recommend APPROVAL.

Cllr Walker advised that she has received an email from planning regarding the layout of the road for the proposed properties North of the Old Bideford Road, Barnstaple application 79375. This includes footpaths and traffic calming. Developer to also lay scalplings along footpath 17 to make it more accessible.

Cllr Bridgeman asked about the Chillpark application as it was not showing as approved on the website. Cllr Walker advised that there were some items that needed to be finalised in order for the Decision Notices to be issued.

Cllr Bridgeman asked about Land at Brynsworthy Lane and the status of that application (80058) Cllr Walker advised that there was a Planning Committee site visit due to take place on the 16<sup>th</sup> July.

Cllr Bridgeman asked about the 5 year housing land supply. Cllr Walker advised that providing two of the previously approved applications were built Fremington Parish Council will only be 43 houses short to meet the target.
