**County and District Councillors' Reports**

Cllr Walker/Cann - Bickington Ward

Cllr Walker explained that the North Devon Council had met last Monday to discuss the local government reorganisation, in November NDC submitted support for the 1-4-5 model. The timetable has been announced and there will be a 7-week consultation process on the proposed structure in February with a decision expected in the summer (June/July/August), the structural change order is expected in September/October along with disposal of assets. A shadow election will take place in May 2027, and the North Devon Council will be dissolved by April 2028.

Cllr Walker announced that the North Devon Council and Pearce Construction are holding a heritage conservation skills boot camp for anyone already working in the construction industry and the RNLI have recently presented its proposals going forward. Not a lot of these changes effect Fremington directly but will around the North Devon coastline, Ilfracombe will only have an inshore lifeboat and Appledore will have a new boat to become the predominant lifeboat.

Cllr Walker informed members that NDC's trade waste service will cease from 31<sup>st</sup> March 2026. It was noted that this is not a statutory service and was running at a loss, there would need to be around a 20/25% increase in prices with no guarantees.

Cllr Biederman – Fremington Ward and Devon County Council

Cllr Biederman explained that as a result of years and years of cuts NDC is really having to balance services and trade waste is not statutory and running at a loss it is disappointing but a stark reality. The government has announced a three-year grant settlement for County Councils, however, there will not be any extra money especially when you factor in inflation. There is a library consultation open which is considering the reduction of opening hours what this means is the facility will still be open but the hours when a librarian is in will be reduced.
