The Chairman informed members that the Police had confirmed patrols had been carried out at Fremington Quay and speed detection has been tested and they will look to carry out a day a month covering two locations, Beechfield Road has been raised but other locations can be requested. A parking issue had been raised by a Cllr but they have not yet contacted PC Lloyd to pursue, and the Police are looking to hold a "coffee with cops" morning and are looking for suitable locations. Members agreed the Beechfield Centre should be offered to support this initiative.

**County and District Councillors' Reports**

Cllr Walker/Cann - Bickington Ward

Cllr Walker reported that since NDC had announced the end of the trade



waste a petition had been received, an extraordinary meeting was arranged to discuss the petition and it was agreed to reinstate the trade waste collection only, there will still be no trade recycling collection, but this will be at a significant cost increase. NDC has approved the budget and with careful management has been able to set a balanced budget, however, the Government settlement means that there will be around a 10% cut to core spending over the next three years.

2602/08 **Devon's Library Consultation**

Members considered the Devon's Library Consultation which proposes to introduce a standardised approach to opening hours. Libraries will be grouped into eight geographical areas, and each band will have the same opening hours. This will see a reduction in opening hours (the availability of a Librarian on site).

Members felt that it was positive that the libraries are being kept open the same hours and as hubs but were saddened that the "Library" service is being diminished and that it is sad to see that the profession is being devalued.

2602/10 **Councillors Questions**



Cllr Walker asked if the parking situation could be monitored around schools especially Sticklepath and Roundswell where "car abandonment and obstructions" are increasing and appear to be worse in the afternoons.

Cllr Sherborne had asked about double yellow lines around Woodville and the school but had been informed there is not a budget.

Cllr McCormack-Hole asked about the possibility of a ramp being installed for Bickington car park to help aid access.
