- 2601/19 **Declaration of interests**
Cllr Tamlin declared a Personal Interest in Item no. 2601/23 planning application 81216.
- 2601/20 **Public Participation Period**

It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the meeting held on the 27th November 2025 as a correct record.
- 2601/22 **Street Naming & Numbering**
Members were provided with a request from LLPG Custodian, Street Naming & Numbering at North Devon Council to name two new properties in Roundswell, it was **resolved**, with no votes to the contrary to agree to the naming proposed of 1 and 2 Potters Wood.
- 2601/23 **Strategic Plan**
Members considered the draft Strategic Plan, after discussion it was **resolved**, with no votes to the contrary, to remove Objective 2.10 *'Lobby the government to reinstate the housing authority's power to pay housing benefits directly to landlords'*. Members agreed that they did not feel that the Parish Council would have significant influence on lobbying of this matter.
