Members were concerned with the amount of traffic speeding through the traffic calming measures along the Old Bideford Road and the lack of obvious priorities, it was agreed to highlight this to DCC.



It was noted that the cars parking along the right hand side of the road as you enter Mead Park were causing a hazard now the development works have started.

Cllr Ms Scott entered the meeting at 7.20pm.

1608/11 **County and District Councillors' Reports** - To receive reports from the County Councillor and District Councillors for information only.

Cllr Cann reported that he has now been given executive responsibility for llfracombe. NDC had employed consultants to review the Waste and Recycling service and the options were to be considered by NDC but could include charging for the green waste service which is currently not received by around 6,000 households.

1608/12 To consider North Devon Link Road Options

It was noted that the consultation deadline had been extended and members were encouraged to submit their views.

Cllr Mrs McCormack-Hole declared a DPI and left the meeting for the following item.

1608/13 To receive recommendation from the Working Party relating to vehicle access in Fremington Cemetery

It was noted that Cllr Mrs McCormack-Hole had a DPI in the Cemetery and she had withdrawn from the Working Party, the Chairman Cllr Mrs Kingdom had joined the Working Party in Cllr Mrs McCormack-Hole's place.

The Working Party had considered the options following the receipt of correspondence from a parishioner experiencing difficulties in accessing a grave without driving along the pathway. Both Age Concern and Social Services had been contacted to ascertain what support the agencies could provide. The issue had not been raised with either organisation, Age Concern stated that they could

St

probably help the parishioner to access the grave in question and they would contact the parishioner direct. Social Services had reported that if the person in question referred themselves they could do a mobility assessment and help would then be provided as necessary. The Working Party recommended that the parishioner be made aware of the help available to them.

The Working Party has visited the Cemetery and witnessed the damage that had been caused by vehicles driving along the pathway, it was also noted that the grass cutting contractor had had to pull several vehicles out that had got stuck when driving along the pathway. It was noted that this is a pathway and not a road and concerns were raised about the close proximity of tyre marks to graves. The Working Party did not feel that it would be acceptable to allow any exceptions to drive along the pathway and felt that the signs were not adequate. It was therefore recommended that two removable barriers be installed to prevent vehicles from travelling along the pathway and keys given to the Parish Council's contractors and Burial Superintendent.

It was **resolved**, with no votes to the contrary, to accept the above recommendations from the Working Party and to reply to the parishioner explaining the help available and to purchase and install two bollards to prevent vehicles from driving along the pathway.

Cllr Mrs McCormack-Hole returned to the meeting.

1608/14 To appoint one member to serve on the Footpaths Committee

It was noted that Cllr Wood had nominated himself at the previous meeting, however, Cllr Wood was already a member of the Committee. It was **resolved**, with no votes to the contrary, to elect Cllr Rennles to the Footpaths Committee following Cllr Mrs Flynn's resignation from the Committee.

- To consider joining the Road Warden Scheme following Chapter 8 training Members considered joining the Road Warden Scheme and it was resolved, with no votes to the contrary, to join the Road Warden Scheme subject to any works being approved by the Parish Council before being undertaken by the Road Wardens.

Cllr Chalmers declared a Personal and Prejudicial Interest in the following item and spoken with the permission of the Chairman.

Cllr Chalmers reported that it had been quite some time since the Parish Council agreed to wait until NDC had taken a view on the support of relocating refugees and other town and parish councils had shown their support towards the scheme. He would now like Fremington Parish Council to show its support and write to NDC expressing its support. Members debated the proposition at length. Concerns were raised about the deprivation in the area which is some of the country's highest, the support that would be available and the lack of details available at this time and it was **resolved**, with four votes to the contrary, to defer any decision until further clarification is obtained from NDC on the questions that have been raised with the Government before the Parish Council takes a view.

To receive update on the Neighbourhood Plan (Cllr Rennles to report)

Cllr Rennles reported that the project plan had been agreed and the group would be looking to access funding in the near future to employ consultants. Cllr Rennles thanked Cllr Mrs McCormack-Hole for the survey work she undertook at the North Devon Show. Cllr Cann asked what the timescale for completion would be as he was concerned at the planning applications that were being received for large developments. Cllr Rennles responded that the completion date was flexible but had been pencilled in for November 2017.

Cllr Ms Scott declared a Personal Interest in the following item.

To receive update on the Coastal Communities (Cllr Cann to report)

Cllr Cann reported that visitors from the Government had been to Fremington Quay and were looking for "shovel" ready projects. NDC has 4 projects and would therefore be submitting the Ilfracombe water sports centre this year and hopefully Fremington Quay next year. As part of the proposals the group would like to look at creating a small scale potter's studio in the Water Tower incorporating the Well and possibly an extension. Cllr Cann asked if the Parish Council would support the project in principle to allow plans to be drawn up for consideration. It was **resolved**, with no votes to the contrary and two abstentions, to support the project in principle.

To consider consultation on the modifications to the Devon Minerals Plan It was resolved, with no votes to the contrary, that if any changes have been made which put the clay deposits at risk the Parish Council would wish to oppose these changes. It was agreed to express the Council's concerns about putting the deposits at risk.

To reconsider election of representative on Fremington Quay Environment Group (Item requested by Clir Cann)

Cllr Cann reported that two Councillors were put forward as representatives on the group and Entrust states that only one active district and parish councillor is allowed. It was **resolved**, with no votes to the contrary, to elect Cllr Mrs Dyson as the Parish Council's representative on the Fremington Quay Environment Group.

It was noted that the Parish Council does not get involved in housing allocation and that it had been found at the last moment that the person in question did not meet the criteria (they have since been allocated the house on the site), but it was in no way connected to the Parish Council. Concerns were raised that Devon and Cornwall Housing were giving incorrect information and the implications this could have on the Parish Council.

Cllr Mrs McCormack-Hole reported that Health Watch have tasked her with identifying members of the community who care for people with dementia to talk to and ascertain their views and needs.
