It was **resolved**, with no votes to the contrary, to agree the agenda as published.

Members considered quotations for the reinstatement of the pathway around Griggs Field and it was **resolved** to appoint Gecko Landscapes to undertake. It was further **resolved**, with no votes to the contrary, to investigate the possibility of a new drainage pipe at the same time.
