1504/01 Apologies

Cilrs D Brailey and B Hockin. It was announced that Cilr Hockin had not attended a Council meeting or Committee meeting since 6th October 2014, therefore disqualifying himself from position of Parish Councillor. It was **resolved** to receive and note the information.

1504/02 **Declarations of Interest**

Cllr Biederman declared a Personal Interest in Items 58799 & 58960 as the applicants are known to him.

Cllr Mrs McCormack-Hole declared a Personal Interest in Items 58735 & 58960 as the applicants are neighbours and known to her.

1504/03 Chairman's Announcements

The Chairman announced that he was coming to the end of his term as Chairman and reported that he had enjoyed the public interaction over the last year which he felt to be important; he passed on his good wishes and thanked everyone for their support.

A vote of thanks was proposed to Cllr Clifton for his role of Chairman over the last year.

1504/05 **To receive a report from the Police**

PC Daffern presented the Police report which is attached as Appendix A. Members of the public were concerned with drugs and behaviour in Aspen Grove, PC Daffern assured the public that it was being dealt with by the Police. The Police were congratulated on the success of catching and dealing with drivers using the one way system the wrong way.

PC Daffern left the meeting.

It was **resolved**, with no votes to the contrary, to note the above item.

1504/11 **County and District Councillors' Reports**- To receive reports from the County Councillor and District Councillors for information only. Cllr Biederman reported that DCC is investigating the possibility of residents' parking along Higher Road which would be charged at £30 a year per permit, along with double yellow lines on the opposite side of the road to the play area and between nos. 54-57 Beechfield Road, and a consultation should be coming to the Parish Council in the near future. Cllr Biederman also reported on the work being undertaken to provide 16-25 with appropriate careers advice and getting them into employment and also the importance of reporting an suspicions of child exploitation. Lastly, Cllr Biederman informed members that the Police will be undertaking speed awareness with the children from the primary school at the end of April.

Cllr Cann asked what the criteria for residents' parking is and Cllr Biederman was unsure but it is being investigated.

Cllr Turner commended Cllr Biederman for the work he had undertaken with regards to the residents' parking and yellow lines.

1504/12 **To receive recommendations from the Defibrillator Working Party** The following recommendations were received: -

- 1. That the Parish Council purchases a Cardiac Science Powerheart G5 CPRD Defibrillator Unit at a cost of £1,045 + VAT, the cost of which to be met from General Reserves.
- That the Parish Council purchases a Rotaid Solid Plus with alarm (outdoor cabinet) at a cost of £295 + VAT, the cost of which to be met from General Reserves.
- 3. That the cabinet and defibrillator are installed in the foyer below the Parish Council Offices. The Parish Clerk has written to all the interested parties and no one has raised any objections to this location, the Handyperson should be able to install the cabinet as this cabinet does not require an electricity supply.
- 4. That the Parish Council meets the annual cost of £300 for training of six Councillors who can then cascade the information down to members of the public.
- 5. That the Parish Council purchases a training unit at the cost of £350 + VAT, the cost of which to be met from General Reserves, that Councillors can use within the community to help with cascading the information from training down to members of the public.
- 6 That the Unit meets the requirements to be placed on the South West Ambulances data base, this includes the annual training and monthly inspections of the equipment which could be carried out by the Handyperson.

Members were concerned that the foyer is supposed to be locked at night and therefore members of the public would not be able to access the defibrillator. It was **resolved**, with two votes to the contrary from Cllrs C Bell and Wood, to refer the item back to the Working Party which is given delegated powers to purchase a defibrillator, cabinet, training unit and appropriate training all to be installed in a location that is available 24hours a day.

1504/13 **To receive and consider response from Pearce Construction relating to the Community Orchard at Lagoon View**

Members were informed that Pearce would not transfer the ownership of the land but would look to licence the orchard use. Mr John Wilson, Secretary of the Lagoon View Community Orchard, thanked the Council for its offer to take the title and informed members that the Association would be looking to lease the land from Pearce. Members were concerned that as part of a planning condition this land is supposed to be designated as amenity land and it was **resolved**, with no votes to the contrary, to investigate the future of the land and its designation with planning enforcement.

1504/14To consider response to consultation on the proposed main changes to the
North Devon and Torridge Local Plan

Members considered the proposed main changes and it was **resolved**, with one vote from Cllr J Bell against, to express the Council's grave reservations and opposition to any residential development at Yelland Quay to facilitate economic development. The Parish Council welcomes the removal of the Ashbed site from the Plan.

1504/15 North Devon Council – Planning Appeal

North Devon Council, the determining Authority, has asked for any further comments from this Parish Council to be forwarded to The Planning Inspectorate on the following planning appeal:

57663 Proposal: Outline application for up to 135 dwellings plus infrastructure including the creation of a vehicular access to B3233, provision of open space, landscaping, allotments, ponds & other associated development – all matters reserved except access (amended details received relating to a revised position for the access, associated drawings and a further addendum to the environmental statement) Location: Land adjacent to the B3233 West Yelland, Yelland, Barnstaple Applicant/Agent: Welbeck Strategic Land LLP

It was **resolved**, with no votes to the contrary, to reiterate the Parish Council's previous recommendation of REFUSAL. The proposed development would be a visual intrusion on the landscape and would have a significant adverse impact on the internationally important Taw Estuary, Biosphere and Tarka Trail. This area has some of the very best agricultural land in North Devon and much of the area is grade 2 or 3 agricultural land which we cannot afford to lose if we are to maintain any semblance of sufficiency in sourcing local food. Much of the area falls within flood zone 3. The development would perpetuate and add to the notorious example of Ribbon Development along the B3233 between Fremington and Yelland and would be contrary to good planning guidance. The development would be visually intrusive in the Taw landscape and would be contrary to the long held policy of not permitting development to the north of the B3233 in order to protect and maintain the open vista of the Estuary and Biosphere. The site is not well related to services or local centres. The increase in traffic would add to existing congestion at the Cedars Junction. The application is a major departure from the Local Plan. This green field site is not in the emerging North Devon Local Plan. There is already adequate land allocated nearby for over 1200 dwellings at Larkbear, Tews Lane, Allenstyle, Fremington Army Camp and Glenwood Farm. The site is outside of the Development Boundary for this locality as shown in the emerging North Devon Local Plan. The site is divorced from any substantial settlement and development needs could be met in a better location. The proposal does not provide identified infrastructure and community needs. There are recent approvals and sites identified and supported in the emerging Local Plan that would more than meet the 5 year housing land supply. The emerging Local Plan already identifies sufficient sites to meet the 20 year land supply in better locations. Given the availability of alternatives this site is not required.

1504/16 North Devon Council – Planning Applications

The District Councillors were reserving their final views on the applications until they were in full possession of all the relevant arguments for and against

58735 Proposal: Extension to dwelling Location: Police House, Bickington, Barnstaple Applicant/Agent: Mr A Surridge

It was **resolved**, with no votes to the contrary, to recommend REFUSAL as this would have an adverse impact on the amenity of neighbouring properties given its close proximity.

58799 Proposal: Installation of underground electricity cable between the wind turbine & point of connection to grid network Location: Lower Litchardon Farm, Newton Tracey, Barnstaple Applicant/Agent: Mr J Pearson, RSJ 2 Energy Ltd

It was **resolved**, with no votes to the contrary and one abstention from Cllr Biederman, to pass the following comments to the planning authority, If the North Devon Council is mindful to approve this application the Parish Council would like assurance that minimal damage is caused and all hedgerows are reinstated and fields made good following any works.

58872 Proposal: Extension to dwelling Location: 2A Chilpark, Fremington, Barnstaple Applicant/Agent: Mr G Price

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to the extension not being used as a separate dwelling and no adverse impact on the amenity of neighbouring properties.

58906 Proposal: Extension to dwelling Location: 59 Beechfield Road, Fremington, Barnstaple Applicant/Agent: Ms N Davie

It was **resolved**, with no votes to the contrary, to recommend REFUSAL as the proposed extension is right on the boundary line and would have an adverse impact on the amenity of the neighbouring properties.

58926 Proposal: Extension to dwelling to create dependant relatives annexe Location: 36 Juniper Court, Roundswell, Barnstaple Applicant/Agent: Mrs N Busby

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to no adverse impact on the amenity of neighbouring properties.

Cllr Biederman left the meeting and did not return.

A member of the public raised concerns relating to native and protected species of wildlife that would be effected by the following proposal.

58960 Proposal: Installation and operation of a single 500KW wind turbine & access track on agricultural land at Woolmers Farm with an overall maximum tip height of 74m
 Location: Land at Woolmers Farm, North Lane, Bickington, Barnstaple Applicant/Agent: Mr P Tucker

It was **resolved**, with no votes to the contrary and one abstention, that the Parish Council feels there is insufficient information to be able to consider the application.

Cllrs Turner and C Bell left the meeting and did not return.

58994 Proposal: Extension to dwelling & conversion of attached garage Location: 55 Lynhurst Avenue, Sticklepath, Barnstaple Applicant/Agent: Mr & Mrs M & J Walker

It was **resolved**, with no votes to the contrary and one abstention, to recommend APPROVAL subject to no adverse impact on the amenity of neighbouring properties.

58995 Proposal: Erection of garage with a bedroom above attached to the side of existing house
 Location: 7 Higher Westlake Road, Roundswell, Barnstaple
 Applicant/Agent: Mr J Knowles

It was **resolved**, with no votes to the contrary, to recommend APPROVAL subject to no adverse impact on the amenity of neighbouring properties.

59059 Proposal: Formation of school bus drop off point & associated landscaping/parking at bus shelter No 294-007 Location: Woodville, Sticklepath, Barnstaple Applicant/Agent: Mr S Snooks, North Devon Homes

It was resolved, with no votes to the contrary, to recommend APPROVAL.
