# 1403/21 Public Participation Period

The Chairman of the Roundswell Residents' Association addressed the Committee with concerns from the Association about Health and Safety surrounding the Claypits. The Residents' Association is concerned that the proposed development does not provide a secure boundary, it is an area where children would like to play and could prove very dangerous, the water is contaminated and there are several places where the water can get quite deep amongst other H&S issues. The Residents' Association is also concerned at the possibility of fly tipping along the road. It was **resolved**, with no votes to the contrary, to write to the North Devon Council expressing the concerns of the Residents' Association; it was further **resolved**, with no votes to the contrary, to place an item for discussion on the next Full Council Agenda.

The Chairman of the Residents' Association left the meeting and did not return.

A resident was concerned about the amount of potholes in the area and the poor quality of patching leading to a bigger pothole requiring repairing. It was **resolved**, with no votes to the contrary, to write to Devon County Council on behalf of residents with a courtesy copy to Cllr Biederman.

A resident raised concerns about the health service and DCC's budget cuts, and another resident asked Cllr Biederman if he had obtained a copy of the licensing minutes and the minute number where illegal taxis was discussed, Cllr Biederman confirmed this would be in his report.

The Chairman proposed and it was unanimously agreed that item 20 **To consider public reaction to new Post Office layout in Fremington** (Item requested by Cllr Wood) be brought forward to this point in the meeting.
