She also reported that Western Power were still doing various work around the Bickington area and the new trampoline centre at Roundswell was being well used by the community.

Cllr Biederman reported that he had a motion going through DCC relating to health cuts and at the last meeting at NDC he had supported saving services, he urged the public to write to our MP to ensure their voices are heard in North Devon and services are saved.

Cllr Rennles reported that the Steering Group met last week and had an in depth discussion with reference to employing external experts to take the project forward, such as a Project Manager. Cllr Rennles further reported that a consultation event will be held on the 5th November 2016.

1610/12 To consider a request to place a kerb on a burial plot in Fremington Cemetery

This matter was considered and it was **resolved**, with no votes to the contrary, to approve the request.

Cllr Turner proposed that item 14 be brought forward and it was **resolved**, with ten votes for and four against to move the item forward to this point on the Agenda.

To consider commissioning an independent asbestos report on the adoption of the open space on the former army camp development (Item requested by Cllr Wood)

Cllr Wood outlined the reasons why he considered it was important to have an independent report to reassure the public. Councillors discussed the matter in depth and it was **resolved**, with seven votes for, three against and four abstentions, not to commission an independent asbestos report.

To receive update and recommendation from the working party on the adoption of the open space on the former army camp development site Councillors discussed the fact that the developers had submitted certain layout changes but discussions are ongoing.

It was **resolved**, with nine votes for and five abstentions, to progress with the acquisition and continue with the negotiations relating to electricity, water and sewage.
