Declarations of Interest

Cllr Rennles declared a Personal and Prejudicial Interest in Item 1601/18 planning application 62123.

1701/03

Chairman's Announcements

The Chairman informed members that a member of the Northern Devon Healthcare Trust was not available to attend the meeting and the representative had said that it would be more valuable if someone attended a meeting when more is known about the upcoming Acute Services Review. Members were informed that the engagement period for the co-location of stroke services had been extended until the end of January and details of how to respond had been circulated.

Cllr Mrs McCormack-Hole informed members that there was another consultation taking place at Petroc on Friday at 2pm to gain the views of services users.

1701/04

To agree the agenda between Part A and Part B (Confidential)

Cllr Biederman proposed and it was unanimously agreed to bring item 1601/05 forward on the Agenda. It was **resolved** to agree the agenda between Part A and Part B (Confidential).

1701/05

Discussions with the Commercial Director and Operations Manager from Stagecoach on the recent changes to bus services and fares

The Chairman welcomed Mr Bailey and Mr Harbour to the meeting and explained the letters of objection to the removal of service 8/8A that she had received from members of the public and the problems people from Woodville are now experiencing in accessing services. Mr Bailey explained that the service 8/8A has not proved financially viable, they linked the service with the Whiddon Valley service which has also proved unsuccessful so in September 2016 Stagecoach decided to withdraw the service which is not subsidised by Devon County Council. The service 12 is subsidised by DCC and it was acknowledged that there was scope in this service to cover the withdrawal although the current route does not allow access to services.

Members of the public raised further concerns about not being able to access services and the isolation that is being experienced. Members of the public also raised concerns about the lack of consultation on the removal of the service and the replacement service.

Stagecoach agreed that it would speak to DCC to see if the service 12 could access some of the services that used to be accessed by the 8/8A service.

Other issues relating to buses being late and wrong ticket prices being charged were also discussed with Stagecoach.

It was suggested that a co-ordinated transport plan was required for the area and after much discussion it was **resolved**, with no votes to the contrary, to try and bring all interested parties together to try to co-ordinate services and where the money from new developments for transport is being and should be spent.

Cllr Ms Scott, Mr Bailey, Mr Harbour and five members of the public left the meeting at 7.55pm.

1701/07 Public Participation Period

A member of the public raised concerns relating to planning application 62199 and explained that the proposal would turn a bungalow into a five bedroomed house which would be over-intensification of the site, out of keeping with the area and have an adverse impact on neighbours.

It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the meeting on the 5th December as a correct record. Cllr Mrs Kingdom duly signed the minutes.

Cllr Mrs Flynn reported that there are problems with Tews Lane which are being addressed.

Cllr Cann reported that the Mead Park Appeal had been allowed and expressed his disappointment, however, the proposal for the erection of one dwelling in Mead Park had been refused as had the application to build on the informal green at Hollamoor View. Cllr Cann informed members that the Chief Executive of NDC had been investigating the issue with the surface water at the sports field in Tews Lane and hoped this would progress.

Cllr Wood reported that he had called in to planning committee the applications for the trees at Brake Wood Close.

Cllr Biederman echoed Cllr Cann's disappointment in the Mead Park application being allowed, and explained that the some of the roads in Allenstyle were being resurfaced by DCC, these did not include those that will be resurfaced by the developer once the development is complete.

It was **resolved**, with no votes to the contrary, to appoint Cllr Biederman to the Footpaths Committee.

Members considered the proposition. It was noted that the Council should be as open and transparent as possible and ward members are best placed to raise issues, it was agreed to remain with current procedures.
