Chairman's Announcements

The Chairman announced that the contractor had completed the works to create refuge places for pedestrians along the BOAT Road to a high standard.

1702/35

Public Participation

A member of the public agreed that the refuge places along the BOAT Road work well although some more markers are required to highlight the dangerous areas. It was noted that the passing place sign had still not been replaced, Cllr Biederman confirmed it was on DCC's work list. The member of the public raised concerns about the amount of boatmen parking in the passing places, it was agreed that the Clerk would provide some signs to the residents which could be placed on cars parking in the passing bays explaining the importance of passing places along a single track road and informing them that they can apply to the Parish Council for the code to use the boatmen's amenity area. It was noted that BT appeared to be marking out the highway for works, no notification of these works had been received.

A member of the public asked if the overflow car park would be opened. It was noted that a funding application had been submitted to undertake improvement works to the car park, subject to Committee approval, and that the car park would be opened before Easter.
