Declarations of Interest

Cllr Ms Scott declared a Personal and Prejudicial Interest in Item 1703/14 as her parents live at the Quay and Item 1703/26 application 62472 as the applicant is known to her.

Chairman's Announcements

The Chairman announced that the website had received nearly 7,000 views in February, it was noted that Mrs Steer had undertaken the project to re-design the website and the Council thanked Mrs Steer for her hard work. It was further noted that the Parish Council's Facebook had been shared several times. The Chairman reminded all members of the importance of reading their paperwork and asking for clarification where required ahead of meetings so informed decisions can be made and reported that Westward Pathfinder had been taken up on their offer and were undertaking clearance works in Roundswell.

The report was circulated and is attached as Appendix One. It was **resolved** to note the report. Whilst members were grateful to receive the report it was noted that more detail would be helpful. Cllr Rennles asked if clarification could be sought on whether or not it is illegal for a bicycle to travel on a pavement. It was noted that the concerns raised at the last meeting relating to road traffic incidents on the main road through Yelland had been passed to the Police who had confirmed they would carry out speed checks in the area.

Public Participation Period

A member of the public raised concerns about cyclists on pavements along Church Hill and the conflict of residents walking out of their front door. The member of the public also raised concerns about the traffic lights and distance from the property.

Highway issues - update 1703/09

Cllr Biederman reported that the road surface in Allenstyle Gardens, Close and View had been resurfaced and the rest of Allenstyle would be resurfaced by the developers once the development has been completed. Cllr Biederman explained that three proposals for the Cedars roundabout were being presented to the HATOC meeting at the end of March and the adoption of Military Road was still being held up by a Civil Matter and a dispute over land ownership.

Cllr Mrs Flynn asked for clarification on whether or not NDC recycles Tetra Packs, Cllr Cann responded that he was not aware that NDC does but there are facilities in Supermarket car parks.

Cllr Chalmers asked if NDC would be carrying out an education program on what can be recycled. Cllr Cann explained that education and awareness was key to the success of the changes.

Cllr Wood asked for clarification on how the emptying of green bins will be administered. Cllr Cann explained that you would opt into the service either online, over the telephone or in person and would be charged accordingly.

Cllr Turner asked about arrangements for green bins for the Roundswell Residents' Association. Cllr Cann confirmed that he would investigate.

Cllrs Mrs McCormack-Hole drew members' attention to the report she had produced on promoting independence and asked that if members are available could they attend the events.

It was **resolved**, with no votes to the contrary, to note the information.

County and District Councillors' Reports - To receive reports from the County 1703/11 Councillor and District Councillors for information only.

> Cllr Mrs Flynn congratulated Cllr Cann on all his efforts with the clean-up programs he has been running throughout the district. The Council agreed and thanked Cllr Cann.

> Cllr Matthews reported that there had been an incident earlier in the day involving three vans which had caused traffic disruption. He further reported that the yellow lines in Woodville and Bickington Road were now in place and because they are double vellow lines which are enforceable all day every day they do not require signs. Cllr Matthews informed members that DCC is currently undertaking a traffic survey at the top of Sticklepath which is a result of the developers of Larkbear wishing to use the Old Torrington Road to access the development.

> Cllr Cann reported that an Osprey Pole had been installed on the Gaia Trust land which had been purchased in partnership with the Coastal Communities Team and a screen would be placed in the Heritage Centre. Cllr Cann further reported that a TAP application had been submitted to NDC for improvements to the existing and overspill car park at Fremington Quay, it was noted that if funding is approved it would require consent from the Committee to proceed. Cllr Cann reported that air pollution samples had been taken at Cedars roundabout and no problems found, further investigations and tests would be carried out in Bickington.

> Cllr Biederman reported that with further Government cuts both NDC and DCC have had no choice but to increase Council Tax with NDC raising by 2.99% and DCC by 4.99%, although 3% of this is ring fenced for social care. Cllr Biederman reported that he had taken part in the hospital march and explained that no decisions have been made yet. He had also met with three refugees who were temporarily housed near Torrington and do not have any family in the country.

Cllrs Biederman and Chalmers declared a Personal Interest in the following item.

Cllr Matthews left the meeting.

Cllr Ms Scott entered the meeting at 7.59pm.

Two applications for co-option were received and circulated to members before the meeting and as follows:

The Chairman proposed and it was seconded by Cllr Chalmers that voting on this item should be undertaken by a Secret Ballot. It was **resolved**, with no votes to the contrary, to vote by Secret Ballot.

Each candidate was asked to speak in support of their application and answer questions.

Voting slips were issued to all Councillors and following a vote it was **resolved** to co-opt Ms Louise Goodger (7 votes to 5) to Fremington/Yelland Ward. The Declaration of Acceptance of Office was signed and delivered.

1703/13 To receive update on the Neighbourhood Plan (Cllr Rennles to report)

Cllr Rennles reported that the Steering Group had received a presentation from DCC on the proposed Bickington Link. Youth Consultations were ongoing and the Community Facilities audit was underway.

Cllr Chalmers reported that he and Cllr Mrs Kingdom had attended Flood Warden training which would feed into the Neighbourhood Plan.

Cllr Ms Scott declared a Personal and Prejudicial Interest and left the meeting for the following item.

To receive update on the Coastal Communities Project and the Water Tower Project at Fremington Quay (Cllr Cann to report)

Cllr Cann reported that the Fremington Quay Environment Group and the NDC had paid for an Architect to draw up a scheme following the Parish Council's support in principle to the scheme and asked if the Parish Council would be willing to submit the planning enquiry which would mean the fee is waived. It was noted that any agreement was to the concept and the detail would have to come back to the Parish Council for approval and the Fremington Quay Environment Group would be the vehicle to raise the funds if the scheme was acceptable/achievable. It was **resolved**, with no votes to the contrary and four abstentions, for the Parish Council to submit the Planning Enquiry.

Cllr Ms Scott returned to the meeting.

1703/15 To receive Cllr Mrs Flynn's resignation from the Tews Lane Committee and Fremington Quay Committee from the 1st April 2017

It was **resolved**, with no votes to the contrary, to receive Cllr Mrs Flynn's resignation.
