Declarations of Interest

Cllr Rennles declared a Personal Interest in Item 1707/17 application 63070 as the applicant is a family member.

Cllr Turner declared a Personal Interest in Item 1707/16 as Chairman of the Roundswell Residents' Association.

Cllr Miss Goodger declared a Personal Interest in Item 1707/14 as it is close to where she lives.

Cllr Cann declared a Personal Interest in Item 1707/14 as the applicant is known to him and item 1707/17 application 63182 as he uses the vets.

Chairman's Announcements

The Chairman informed members that she had recently attended the opening of the new interpretation boards and scrape at the Nature Reserve. The Chairman also informed members that a presentation had been made to students of Petroc to thank them for the work they have undertaken throughout the parish.

It was resolved to agree the agenda between Part A and Part B (Confidential).

1707/05

Public Participation Period

The representatives from Baker Estates addressed the Council and outlined the proposal for the former Oakwell Care home in Bickington. They explained that indepth consultations had been carried out with residents and the wider public and most concerns had been addressed. The Police Architecture Liaison Officer also had positive comments on the proposals.

A member of the public asked why the public has to pay £36 a year for the green waste collection and where the figure had come from.

1707/06

It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the meeting on the 5th June 2017 as a correct record. Cllr Mrs Kingdom duly signed the minutes.

Highways issues – update

Cllr Ms Scott reported that there was a pit forming on the Old Bideford Road and she would report via DCC's website.

Cllr Mrs McCormack-Hole reported on the Acute Services Review and the next stage of the consultation.

PC Lucy Robinson and PC Charles Northcott entered the meeting.

1707/09 To receive a report from the Police

PC Lucy Robinson explained that there had been several break-ins at the Muddlebridge Allotments but there were not any suspects. PC Lucy Robinson read the crime report which covered the period 1st June 2017 - 1st July 2017.

Members asked if a Police Presence and/or report could be received for every meeting. PC Lucy Robinson and PC Charles Northcott explained that there were now only four Beat Managers in Barnstaple which has left them very short staffed, work has to be prioritised, procedures have changed several times over the last year and where possible a report will be provided.

A councillor was concerned that Roundswell appears to always have the worse crime rate compared to the rest of the parish. PC Lucy Robinson and Charles Northcott explained that Roundswell is a densely populated area and has a lot of retail both of which increase crime rates.

PC Lucy Robinson and PC Charles Northcott left the meeting.

County and District Councillors' Reports - To receive reports from the County 1707/10 Councillor and District Councillors for information only.

Cllr Mrs Flynn reported that if developers are not complying with the conditions set by planning permission to inform NDC and to log as many details as possible so the conditions can be enforced.

Cllr Cann reported that NDC had issued notice against Linden Homes for noncompliance. Cllr Cann gave an update on the roll out of the new waste and recycling service. Cllr Cann explained that consultants had designed the collection routes and unfortunately they were too large, two new routes have now been implemented and a company was employed to deliver the kerbside caddies. Cllr Cann explained that DCC direct to NDC where the green waste is taken and the subscription to the service had been huge. Cllr Cann had visited two of the trial areas for the three weekly collections and the scheme seems to be working. All in all once the service is up and running the recycling rate should increase, the service will be cost effective and will produce savings.

To receive update on the Neighbourhood Plan (Cllr Rennles to report) 1707/11

Cllr Rennles informed members that he had attended the Fremington School Fete and had spoken to families. At the recent Steering Group meeting members had discussed the draft questions which will be finalised and sent back to the Steering Group and Council for approval before they are distributed. Cllr Rennles further informed members that the help of all Councillors would be required to distribute and collect the surveys to each and every household within the Parish. It was noted that a sheet explaining the Parish boundaries would be included and there would be an online option to complete the survey.

1707/14 To consider support for Application for Green Waste Collection Charge Concession

Members considered the application, it was noted that the land maintained is actually highway land and on the Parish Council's schedule for cutting. It was therefore **resolved**, with one abstention, that the Parish Council is unable to support the application.

Cllr Miss Goodger returned to the meeting.

1707/15 To received recommendation from the Working Party on possible locations for investigation as Community Landing Sites

The Working Party recommended the following sites for consideration:

- 1) The Fremington Army Camp, grid reference 51°04′31″N 004°07′31″W. Please be aware that this army camp is currently under construction which is why we felt it was a possible area, the Google map picture is not an accurate representation and we did think if you found this suitable then it could be incorporated into the make-up of the football field currently under construction there.
- 2) Tews Lane Playing Fields, Tews Lane, Bickington, Devon, EX31 2JU
- The field behind the Children's Hospice South West Redlands Road, Fremington, EX31 2PZ, please be aware this is private land and we are unsure about any lighting, but we wanted to see if this was an option at all.
- 4) Beechfield Playing Field, Beechfield Road, Fremington, EX31 3DD
- 5) The Grassed area of Allenstyle, near EX31 3DZ
- 6) The grass area near Petroc Brannams, or even possibly the car park area.
- 7) The car park area at Dunelm at Roundswell Retail Park EX31 3RY
- 8) Next to the Bowls Green EX31 2PP there is a small plot of land which may be suitable.
- 9) Ellerslie Park, near Ellerslie Road EX31 2HT

Concerns were raised about putting forward land within private ownership before contacting the landowners and it was **resolved**, with no votes to the contrary, to agree in principle to investigate the suggested sites and for the Parish Clerk to try and contact the landowners before submitting any land in private ownership for consideration.

The correspondence was circulated prior to the meeting. Cllr Turner gave an overview of the problems being experienced with fly tipping and litter in the area and asked if the District Council has authority over the housing association to take action against its tenants. Cllr Cann explained that there had been ongoing problems for years, NDC's wardens have visited but the problem is identifying the offenders, action cannot be taken unless you can prove who has tipped. NDC does not have any authority over the housing association and the association would still need to prove who was responsible. It was **resolved**, with no votes to the contrary, to write to NDC to express the Parish Council's concerns and ask NDC to meet with the housing association to explore solutions.
